## FROM THE HELM

## COMMUNITY CENTER REVITALIZATION

During the past month much activity has been on-going. Pictures of the five alternative architectural exterior styles were posted on the website and photos displayed in the office windows and on the wall of the multi-purpose room, providing owners a choice of the outside design of the Community Center complex when ultimately finished. Ballots for design selection were made available from the office and on the website for downloading. Unfortunately the ballots mentioned in the last *Seashore News* article were omitted when distribution was made.

Two "Owner Public Hearings" were conducted to provide further guidance to the Revitalization team. Information from these hearings will be carefully considered as the team continues its work. Several owners commented that the time available for response on exterior architectural choice was too limited, exacerbated by the holiday time of the year and the ballot forms not being distributed with the January issue of the *Seashore News*. In agreement with the comments, the team has decided to extend the voting cutoff 30 days, ending February 13, to allow owners

who had not cast ballots more time to make their desire known. This extension was immediately posted on the Niguel Shore website: [niguelshores.org](http://niguelshores.org), where photos and ballots are still available. The office has an ample supply of ballots ready, and the previously omitted ballots from the *Seashore News* are enclosed with this issue for use by any owner who has not selected an alternative. **All owners who have not voted are urged to make their selections known as soon as possible, but certainly before February 13 when the polling will end.** Please return the completed ballot to the office in person or by mail.

The office staff completed their recommendations for a floor plan including usable interior space for an efficient handicapped accessible office, and the decision was made to include a small Community Activities Room in the new building to provide meeting space for committee, small group, and Board meetings. The office space and the community activities room combined to create a new building of about 1,900 sq. ft., as mandated by the Board. The final design of the new office building will not be determined until the desired style design is decided.

## COMMITTEE REPORTS

---

### ARCHITECTURAL CONTROL



This is the last of three articles about water problems and your home. We finally look at water that causes problems at or below the ground level.

Good drainage ensures that rainwater is carried away from your property to the street. From the street it will flow to a storm drain and then to the ocean. If you live on a downward slope you can not send any water from your property down the slope or you could cause erosion and/or slope failure! Make certain that underground drains and above ground swales or gutters are clean and free of debris that can prevent the water from flowing properly.

Always keep soil at least four inches below your weep screed or the lowest portion of your exterior sheathing. In addition, the soil should slope away from the structure to prevent pooling along the concrete slab. Both of these conditions apply to your neighbor's home as well, if you have access to their

side wall. Concrete slab can absorb this pooled water over time, and allow moisture to penetrate and damage structural wood in walls as well as flooring that is placed on the slab.

Do everything that you can to encourage proper drainage on your property to protect your home and your neighbor's home. Remember to follow *Rule 3118-2-b* in your Niguel Shore Community Association *Rules and Regulations* to include a drainage plan with any submittals that alter the drainage on your property.

### TRAFFIC AND SAFETY



#### MARINER GATE:

The gate officers have reported that the number of vehicles being denied access through the front gate has risen dramatically in the last two months because the residents have failed to call in their authorization ahead of time. This includes your guests, contractors, delivery, and repair people. Not only is this an inconvenience to you, it is causing a major back-up of vehicles in the guest lane.

We have over 21,500 vehicles a month pass through in the guest lane, which equates to an average of 70 cars per hour during a weekday. The gate officers do their best to keep the line flowing, but when a car arrives without authorization, the flow is interrupted and a back-up is created in a hurry.

### LANDSCAPE



Many yards are being overwatered, creating run-off problems. Too much water is more hazardous to the plants than too little water.

If you see a broken sprinkler or a place that is being overwatered in the common area, please call the office.

We are still having a problem with dog owners not picking up their dogs' waste. Hey, please show some consideration to your neighbors.

- ▶ Redesign of handicap entrance gate to pool.

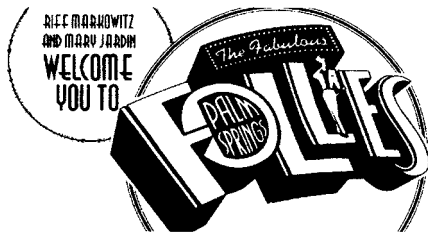

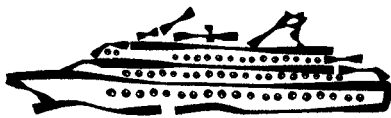

## DISASTER PREPAREDNESS

A close watch is being kept on reports from London that Avian Influenza (H5N1 strain) has spread from East Asia to Romania, Greece, and Turkey. The latter has confirmed infected poultry in 10 of the country's 81 provinces – including Istanbul, Bursa and Ankara. (*Spiegel online, Jan. 9, 2006*)

The H5N1 strain is a highly contagious virus that mostly affects poultry. It can currently be transmitted only from birds to humans, with poultry workers and children its main victims.

“There have been no cases - anywhere in the world - of a human contracting bird flu from another human. Nevertheless, health experts remain concerned that the virus could mingle with a human flu virus and mutate into a human-to-human strain if enough people catch it from exposure to slaughtered birds.” (*Spiegel, Jan. 9, 2006*).

The World Health Organization (WHO) is taking an active role in better communication, information exchange, tests and the immediate culling of poultry stocks in affected areas.

In the meantime protect yourself and others by having a flu shot (the season is not over until March), and observing basic tenets of hygiene if you have a cold or flu.

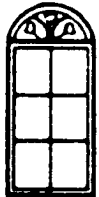

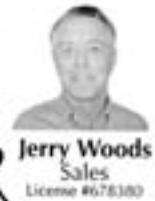
