BOARD ACTIONS



- Approved a reduced landscape watering cycle in an effort to eliminate standing water wherever possible.
- Continued to review the various proposals with regard to water mediation requirements and the asphalt overlay project. Additionally, the Board approved the establishment of an *ad-hoc* committee to oversee the projects. Sam Johnson will chair the committee whose membership is composed of Roy Dohner, Dave Ontiveros, Maintenance Manager Dave Crook and General Manager Skip Eissfeldt. George Evans will serve as Board liaison.
- Reviewed the progress on the Community Center revitalization project.
- Conferred with legal counsel on legal and litigation issues and conducted several hearings and imposed fines.
- Accepted the resignation of Dick McNair from the Communications Committee.
- Approved a resolution which would prohibit the building of a home on two adjoining lots.
- Approved the creation of a Search Committee to find a permanent replacement for the general manager position.

FROM THE HELM



In recent issues of the *Seashore News*, there have been letters concerning related topics that keep recurring. So I am going to try to answer them.

Several letters had to do with parking rules and towing. The place to start is a letter that had to do with using garages for something other than storing vehicles. Our staff cannot inspect garages. Rule 6405 explains that a vehicle is to be parked in garages or driveways. In some cases residents have legitimate reasons to park in other designated parking spaces and our rules provide for that. We can respond to complaints about using garages improperly. The city also has rules about garage usage. To help us with this issue complete a Homeowners Request Form so we have the complaint in writing. All complaints are confidential.

Now, what about vehicles that do not have a bar code, a visitor pass or service pass? Refer to *Rules 6401* and *6440-3e*. Our staff is committed to keeping the community as safe as possible. A big part of doing that is to deal with vehicles that may not belong here. In most cases the rules provide for a warning before towing, but there are times when immedi-

ate towing is called for.

Even when a pass has been properly obtained it must also be properly displayed – on the dash board or hanging from the mirror. A legitimate pass on the seat or floor doesn't work. And though the visit may be brief, the pass must be displayed properly.

The visitor pass that doesn't expire (former no-call list) can be terminated. Just call the office and we'll cancel that pass.

All this leads us to the signs at the gates. By law, certain signs must be displayed even though we have private streets. They must be displayed at each of our five gates. Other associations have only one manned gate and do not have the attraction of easy access to the beach. It is a constant battle to keep the signs to a minimum. But when some people attempt to tailgate we must have a notice in writing that they'll pay the price. At our unmanned gates we must tell visitors how to get in. We'll continue to try to keep the signs at a minimum and in good taste. Speaking of good taste, we aren't happy with the pressed concrete paving in the Garden Homes and we will deal with the problem in the future.

The Communication Committee would love to have more newsy articles. All you have to do is write one and submit it. The article should be 250 words or less.

If you see dogs running loose let us know. Use a Homeowners Request Form. Describe the dog, time and location. Eventually we can identify the owner and take legal action.

And lastly, for now, thank you for the positive comments. We are fortunate to have a good landscape contractor and fortunate to have so much open area common ground.

In 1996 our former CFO set a goal of being 100% reserved by 2005. Even with the costs of replacements going up every year, the Finance Committee and successive CFO's have been able to reach that goal.

We do live in a unique community and as long as we all try to work together we can keep it that way. Heaven knows it isn't perfect, but if you let the committees, the staff, and/or the Board of Directors know your concerns – in writing – we can try to answer you and/or fix it.

Please remember there will be three Board seats open next May.

ARCHITECTURAL CONTROL **COMMITTEE**



Many of Southern Californians over-water their lawns and gardens. Over-watering can lead to higher water bills, breeding areas for West Nile Virus-carrying mosquitoes, and urban runoff that pollutes the ocean.

The Southern California Water Agencies created a Web Site at BeWaterWise.com with information on setting sprinklers properly, gardening with California native plants that use less water, and finding rebates when replacing an irrigation controller, washer, or old toilet.

According to OCbeachInfo.com, a broom rather than a hose should be used to clean driveways and sidewalks. Irrigation flows should be controlled to minimize runoff. This extra water ultimately carries chemicals, animal waste, and other pollution to the Pacific Ocean.

Taking time to check water use may save money, reduce pests, and keep the Pacific safe for swimmers and surfers.

The sheriff has increased the random patrols throughout the community. They are particularly looking for:




