FROM THE HELM



We have lots of things going on in the Shores right now. Here are four of them:

- We welcome Leo Riley as our new General Manger. He will start on March 1.
- The big lawsuit has been settled. The plaintiff finally made an offer to settle and we've accepted that offer.
- The Association has granted an easement to the South Coast Water District to put new sewer pipes under the second tier of the parking lot at the Beach Bluff. The sewer pumping station, now underground near the second tier parking area, needs to be replaced. South Coast will run a line from our present pumping station to a new station on the headlands property. The old pump station will be decommissioned in conjunction with the sewer work. South Coast will install a drain for the foot shower which will be relocated. They will install a potable water line at the Beach Bluff at no cost to the Association.

In April, South Coast will also install a larger sewer line along

Magellan Isle and up Cabrillo Isle to Pacific Coast Highway. They will repave, to our specifications, all the streets they dig up and the Beach Bluff parking areas.

• A second project in the custom home area is what we call water remediation. Natural underground water has existed in the Shores since before the community was started over thirty years ago.

The very wet weather we had last winter exacerbated these long-standing problems and made us realize we must prepare for the next wet winter. The seepage has resulted in the lifting of sections of paving in the custom homes and Beach Bluff parking. Our planned paving project in this area is scheduled for the fall of this year. Before we can repave, we must take care of the seepage.

A geotechnical engineer has developed a corrective plan for the area. Beginning in April of this year, underground drain lines will be installed on the southern sections of Cabrillo Isle and Magellan Isle to capture the underground water and direct it into the South Coast sanitary sewer; this plan also requires the removal of saturated soil under the southern section of Cabrillo Isle and an area near the Breakers Isle Gate.

This project should take about a month. Traffic disruption and limited access to certain homes on Cabrillo Isle will be required. All impacted homeowners will be given advance notice. We'll try to minimize problems. We appreciate your understanding as this important project progresses.

**COMMUNITY CENTER
REVITALIZATION**

The results are in!! Balloting for the preference of the architectural style to be featured in the revitalized NSCA Community Center complex are in. Ballots were tabulated on February 14. Six weeks of balloting by members resulted in a clear choice. A total of 325 valid members voted in the process.

The consensus:

- First place: #3 - "Composite Sketch", 172 votes (53% of members voting.)
- Second place: #4 - "Classic Club", 51 votes.
- Third place: #2 - "Classic Mediterranean", 47 votes.
- Fourth place: "Early California", 34 votes.
- Fifth place (last): #1 - "Existing Style", 21 votes.

The Revitalization Team thanks all of you who expressed your choice.

On February 15, the results of the preference poll were provided to the Board of Directors who voted to accept a proposal from Robert Borders & Associates to commence design of the next phase of the revitalization, a new office building. The Borders firm is renowned for their work on community buildings, the latest being the new large facility at Leisure World.

The work on this project will be extensive and include significant underground provisions for sewer lines and other utilities which will be designed for use in this stage as well as later building phases. After NSCA input provided from our office users and information gathered at the recently held "Owners' Public Hearings" has been transmitted to the architect, a schematic design will be rendered. Special attention will be paid to assure complete compliance with current building and safety codes as well as ADA requirements.

Timing for construction will depend on how quickly we can get established and obtain permits from the city. The city may well require submission to the Planning Commission or even to the City Council should controversy develop. Once through this task, plans will have to go through a plan check after which we will go out to bid. This entire process in the best case will require five months. It is likely that we will start demolition in the fall with construction of the new office, which is estimated to take three months, to follow.

The Revitalization Team will be providing input to the architect early on. Just as soon as preliminary sketches are available they will be displayed in the existing office window. Members' input will be most important at that time. Meanwhile, don't hesitate to call on the team member who lives in your neighborhood.

LANDSCAPE

Thank you for your cooperation in picking up your animal droppings. There has been an improvement but all pet owners need to do their part.

Niguel Shores currently has a large infestation of rats. Therefore, a pest controller is being used to eliminate them. The product used is not dangerous to pets; however it is encouraged that pet food not be left outside as this attracts the rats.

TREE VIEW BLOCKAGE

We have nothing to comment on. Last month we had no complaints or blockage issues. Thank you for your efforts to comply to the rules that make the community a beautiful place to live.

TRAFFIC AND SAFETY



Entry Gate Signs: As you have probably noticed, new signs have been installed at all the entry gates. Many thanks to Steve Leonard who spent a lot of time and effort to make this happen. Our entry gates are now first class, just like our community.

Rule 6407-1: In the future, if you are considering purchasing a vehicle or registering an existing vehicle with the intent to obtain a pass to park it in the community, you need to be aware of the restrictions contained in this rule. The rule states that a vehicle may be given a barcode and parked in view, provided that it is used on a day-to-day basis and that the vehicle does not exceed a 145-inch wheel base dimension and 85 inches overall height dimension (including roof-mounted appurtenances). This rule is being strictly enforced.

Mariner Gate: Our gate officers have reported that motorcycles are entering the community via resident lane by accelerating around the car after the gate arm has been raised, but before the car reaches the swing gate. This is a VERY dangerous practice, as the motorcycle appears out of nowhere and cuts in front of the entering car. Your help in identifying the individuals would be appreciated.

The VANDALISM continues:

- The spa continues to have soap in it requiring it to be drained and scrubbed.
- Coach lamps are an ongoing target especially along the Windjammer slope toe.

These senseless acts are causing everyone unnecessary time and expenditures.

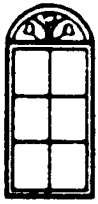

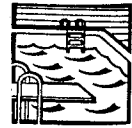
