#### **BOARD ACTIONS**

#### APRIL 5

Approved the minutes of the Special Executive Session of March 30, in which recommended rule changes were considered and reviewed.

Reviewed the plans for the April 8 Disaster Drill with Gerlinda Duffy.

Considered a recommendation to engage a professional financial firm in purchasing CD's, and other insured investments. After discussion, the Board passed a motion to continue with its current practice of self-managing investments through the CFO, controller and general manager.

Reviewed and approved the Camp Hobbledehoy for 2006. Dates will be June 19 – August 18. Rates will remain the same, but a surcharge will be charged for non-NSCA residents and the money deposited to the Association Account.

Accepted the resignation of Ed Adams from the Recreation Committee with regret.

Discussed letters to the Seashore News for the Voice of the People and decided that the President should continue to write responses to homeowner submittals as a valuable commication tool.

#### **BOARD ACTIONS** continued

► Approved a bid from West Coast Paving of \$59,616 for the water remediation project to install and complete a multi-flow drainage system. The system will be installed on Mercator Isle, Magellan Isle, Nauticus Isle and Breakers Isle and work will begin Monday April 17.

► Reviewed a bid from West Coast Paving for \$24,532 to redo the 3 aprons that were finished with stamped concrete not pavers (current method). Bid was tabled and referred to Traffic and Safety Committee.

The general manager reported increasing homeowner complaints regarding service issues with Patrol One. Board directed GM to investigate and pursue any necessary actions through the Traffic and Safety Committee.

Maintenance noted that the Association Mitssubishi TV was in for repair and the cost to repair exceeds the value of the set. Replacement options, were considered and general manager was directed to obtain various bids.

#### <u>APRIL 19</u>

► Passed a motion to accept the consent Calendar which included the appointment of Kathy Jones to the Tree View Blockage committee, the resignation of Gerlinde Duffy as the Disaster Preparedness Coordinator and the approval of the Election Committee nominees – Jack Christiansen, Inspector of the Election, and committee members, Norb Berberich, Bob Borland, Mary Crowl, Gerlinde Duffy, Ceacy Johns and Lee Writer.

► Asked general manager to respond to Sea Terrace II Board regarding their request to have the Association pay for landscaping maintenance for "front yards."

▶ Passed a motion to approve the 2005 Audit and mail out to homeowners.

► Recommended that the general manager post information and details on the Website regarding 1) the Water Remediation construction on Breakers Isle, Mercator Isle and Nauticus Isle and 2) the status of the new entry apron installations on Cassandra Bay and Taranto Bay.

#### COMMUNITY CENTER REVITALIZATION

The Revitalization Team met on April 5 to review the initial schematic drawings of the new office floor plan and four exterior elevations. The team consensus was that the elevation facing Niguel Shores Drive needs additional work on the roof line and entry cover structure to provide a more inviting appearance. Accordingly, our architect, Joe Petitpas, took back various suggestions for incorporation into the design before structural concepts begin.

New drawings and elevations were well received with minor changes that will be incorporated in final conceptual drawings. These concepts were immediately sent to the ACC for pre-review and suggestions. Story poles will be erected for community suggestions. The semi-final plan of the office phase will then be posted on the existing office window so the members may make comments that will be considered before the final plan is sent to the ACC for approval. General color schemes and materials for the exterior will be part of the final plan.

The City of Dana Point has committed to helping us obtain a speedy plan check. We have been advised that this project will likely not require Coastal Commission approval and should proceed with the usual City Planning Commission procedure.

The Team continues toward a demolition target date in October, and is dedicated to a final quality product built in the most cost effective way. Cost and long term maintenance will be deciding factors.

The whole process is now accelerating and decisions are being made. Updates on actions being taken will be posted on the Niguel Shores website

#### MAINTENANCE

Formed joint task force to identify and recommend controls to reduce over-watering and drainage runoff.

<u>Phase I</u> - Collect data, i.e. location of controllers and timers, station values, sprinkler heads types, soil types, and slopes. Compile information onto an electric map of the common areas.

<u>Phase II</u> - Evaluate a sensor controlled irrigation system. Evaluate annual water usage, cost savings potential and rebates from the water district. Evaluate proposals by manufacturers to determine all the costs.

<u>Phase III</u> – Analyze options and make recommendation to the Board.

► This year's budget permitted the replacement of two entrance aprons.

• Contingency plans for entrance gates during power outages are being developed.

• Quarterly cleaning and polishing of the bronze Dolphin statue has been completed.

• No vandalism occurred in March.

## ARCHITECTURAL CONTROL

Many of the homes in Niguel Shores have zero lot lines. There is always an easement on that side. An easement is a property right so that one can enter their neighbor's property for the purpose of maintaining their own property. This is in your deed. Easements are usually 3 feet wide, except for the Villas, where the easement may be 5 feet. Your neighbor cannot deny you access to his property. You bought that right! Please see rules Rules 4151 and 4152 about easements and planting in the easement areas. Your neighbor cannot erect any permanent structure in the easement area. The other side of your home probably has an easement area also, but this is abutting your neighbor's residence and garden walls and that area is eased to them; again, for maintenance. There is no easement to common walls. This applies to the Garden Homes, the Villas and the Sea Terrace homes. In the Broadmoor Homes, your wall is usually three feet in from your property line. Therefore, when you maintain your home, you are on your own property. Please see Rules 3154 - 1 & 2.

Editor's note: Mr. Milner replied directly to the writer of a letter in last month's Voice of the People. The subject was a recent lawsuit in which the Niguel Shores Association was involved. Because of wide-spread interest in this matter, we are printing a copy of his letter to Mr. and Mrs. Jacobs.

#### Dear Barbara and Arthur Jacobs;

In your letter to the Seashore News, you asked about the particulars of the recent lawsuit that was settled out of court. The basic information is available to anyone at the Superior Court in Santa Ana. Due to the fact that a lawsuit was filed, it is pubic information. This was stated in the letter informing you of the \$125 assessment.

However, our corporate council and our litigation attorney, have advised the Board that we should not disclose the name of the plaintiff, the details of the suit or the settlement. The plaintiff could file another lawsuit alleging that he/she was wronged by someone informed of the details by the Association. We have had some evidence that this could happen based on an event that occurred before the settlement was finalized. To protect the Association, and possibly individual residents, we are following the advice of our lawyers.

The Board takes its fiduciary responsibility very seriously and we do not want to expose the Association to the possibility of another lawsuit. This situation did not arise as a result of poor judgment and there is nothing for which we are embarrassed. In fact, we believe the settlement came about because the plaintiff realized the Association had acted legally and that court would probably find in our favor.

Attached is a copy of the litigation disclosure statement included in each escrow to potential new Association members during the time of the pending lawsuit.
