## ARCHITECTURAL CONTROL **COMMITTEE**

It is important to post Work in Progress cards when starting any new construction or remodeling (Rules and Regulations, 3117). The purpose of this card is to ensure that any construction being undertaken in the community has gone through proper channels and has been approved. On many occasions the committee has been contacted to check on "unauthorized construction" only to discover the owner has not posted the card. This takes the time of the committee and sometimes the office staff when they have to pull records to verify approval for a given property. The proper posting of the cards is a very simple way to monitor authorized and unauthorized construction in the community.

After the recent rains, small weeds are growing in many driveways. Please, use a weed killer if necessary.

## TRAFFIC AND SAFETY **COMMITTEE**

- 1. Parking Citations. Remember, the streets in Niguel Shores are subject to the California Vehicle Code. Citations are being regularly issued for parking on the sidewalk, in front of fire hydrants and in front of trash receptacles on trash days.
- 2. Rule 6405-Overnight Parking: The Security Patrol will be citing resident vehicles without Special Parking Permits and/or vehicles with no visible identification parked on the streets between 1:00 am and 6:00 am in violation of this rule. Multiple offenses could result in the vehicle being towed away.
- 3. Dogs OFF the Leash: Dogs are being allowed off the leash in the community and often intimidate those walking nearby. Unless an "incident report" is filled out, no follow-up action can be taken. The information is needed first hand. These reports are confidential. Get a form and fill it out. All will benefit from your effort.

## BEACH BLUFF BARBECUE

The community barbecue will be on Saturday, June 18, instead of Sunday, Fathers' Day.

#### LANDSCAPE COMMITTEE

No palm trees may be planted on private property without approval from ACC.

Regarding zero lot line homes, drainage may not be disturbed and must remain open to the street. On these small lots (even though they are not within the 3' area) trees with invasive root systems should not be planted. Ficus family trees, palm trees and vines have destructive root systems.

A large coral tree was severely damaged in the park behind the Community Center. Many large holes were gouged in the trunks of the tree. If you are aware of who caused this vandalism, please report it to the office.

The newly planted *podocarpus* trees at the Beach Bluff lot look like they are dying. Mr. Wendt, the Landscape Contractor, said it will take a growing season for the trees to adjust in this salt climate. They will sprout out new growth and then die back several times.

#### **VOICE OF THE PEOPLE**

Letters are welcome and limited to 200 words, typed if possible, including name, address and phone number of writer. Refer to NSCA Rule #5221,2,3. Submissions are due on the 17th of the month except in Feb., Nov., and Dec. when due on the 15th of the month.

Lately, when I go walking early in the morning there are groups of people with their dogs running and playing in the open space behind the pool. Is that safe? Not for me. I have had hip surgery recently as well as being hit by an automobile...so I am afraid of being knocked down. After the third day of seeing this group I walked down to the bluff.

Guess what? There was a man walking his dog without a leash in the lot leading down to the grass. But on the grass there were unleashed dogs as well. SOOOO...I turned around and came home.

If the dogs are to run freely...unleashed...we will have to fence an area for them. What about the children? Safety is a concern.

So I ask the question: Is Niguel Shores becoming a Bark Park? I hope NOT.

#### NEW TRAFFIC CONTROL

The Association will complete the asphalt overlay program for over 13 miles of streets in September. This work will end a project that began over seven years ago and will not have to be redone for 25 to 30 years.

The areas to be covered are the Beach Bluff parking area, Breakers Isle, Custom Homes, Sea Terrace I Town Homes, Niguel Shores Drive from Stonehill Drive to the beach, Mariner Drive, and Windward Drive.

The Association views this overlay work as an opportunity to address the growing problem of cars speeding through the community. By slowing traffic in a number of areas through raising speed berms from 3" to 4" and the addition of a few new speed berms in other strategic places, the streets will be safer.

In addition, at critical and potentially dangerous stop streets, double berms will be installed, including the intersection of Niguel Shores Drive and Ports O' Call, intersection of Mariner Drive and Niguel Shores Drive, intersection of Periwinkle and Niguel Shores Drive, and Windward Drive at Selva exit.

Residents may provide input in this matter by the use of the Home Owners Request Form addressed to the Traffic and Safety Committee.


