## OFFICER RECOGNIZED FOR VALIANCY

A hero is a man who does what he can. On June 8 Securitas USA Post Commander David Gonzalez did just that. While on duty at Niguel Shores Community, a resident came screaming that someone was in trouble and shouting for help. Post Commander Gonzalez immediately secured the guardhouse and drove to the scene. There he found a resident with her hand trapped between the garage door and the trunk of her car screaming Please, someone please help me. Oh my God and was in obvious pain. A neighbor nearby said they were calling 911 and help was on the way. The injured party was pleading with the Post Commander to get her hand out. Post Commander Gonzalez attempted to push the garage door up but it would not budge. Officer Gonzalez noticed her purse and keys on the floor. He at once grabbed her keys and turned the vehicle on. He moved the vehicle forward and her hand came free. He then turned the car off and then saw the resident collapse onto the ground. A couple of neighbors helped move her away from the garage door and Post Commander Gonzalez found a blanket to place under her head and a jacket to drape over her until emergency response arrived. As Officer Gonzalez heard the sirens approaching he raced to the front gate to open them however the Sheriff units already had the gates open on emergency status. The Fire Department was next to arrive and then the paramedics. Post Commander Gonzalez had gone back to the scene to ensure the resident was being treated. She was being loaded into the ambulance and taken to a local hospital.If not for the quick action and helpfulness of Post Commander David Gonzalez, the resident may have been in excruciating pain for longer than she had already tolerated. His quick and selfless action by choosing to come to the aid of someone in dire need is more than commendable, it is inspiring.

### MAINTENANCE

It is no accident that our pool water is clean and comfortable. Several of our swimmers have commented that the pool has never been in better condition. In a past article we wrote about Dave Smith who comes in at 4:30 a.m. to have the pool ready for the early morning lap swimmers. It takes daily attention to the chemical feeders, circulation pumps, filters, and heaters, to keep the pool in top condition. This past week we replaced a pump and a heater. All three heaters have now been replaced in the past twelve months.

There comes a point when chemicals will no longer maintain the water at the comfort level we have come to expect. As water evaporates it leaves behind minerals, measured as total dissolved solids. Eventually the solid build up renders the chlorine ineffective, or we have to add levels of chlorine that cause eye irritation and damage to swim clothes. That's what George Cooley calls *tired water* and it becomes necessary to drain and replace 60 to 70% of the water. The pool was closed for a couple of days in June to perform that task. So we lost a couple of swim days during the June Gloom to ensure that we have a summer of healthy, comfortable swimming.

Currently, Scott is finishing classes at Saddleback where he will follow the footsteps of his older sister Heather and attend UC Santa Cruz. He's aspiring to major in Environmental Studies.

Heather utilized her left-handed shooting arm to contribute to the offensive counter, landing her





Independence Day, commonly known as the Fourth of July, is a federal holiday commemorating the adoption of the Declaration of Independence on July 4, 1776, declaring independence from the Kingdom of Great Britain. Independence Day is commonly associated with public and private events celebrating the history, government, and traditions of the U.S.A.

During the American Revolution, the legal separation of the American colonies from Great Britain occurred on July 2, 1776, when the Second Continental Congress voted to approve a resolution on independence that had been proposed in June by Richard Henry Lee of Virginia. After voting for independence, Congress turned its attention to the Declaration of Independence, a statement explaining this decision which had been prepared by a Committee of Five, with Thomas Jefferson as its principal author. Congress debated and revised the declaration, finally approving it on July 4. John Adams wrote his wife Abigail ... I am apt to believe that it (July 4) will be celebrated by succeeding generations as the great anniversary festival. It ought to be solemnized with pomp and parade, with shows, games, sports, guns,

bells, bonfires, and illuminations, from one end of this continent to the other, from this time forever more.

#### **Observance:**

- ★ in 1777, thirteen gunshots were fired, once in the morning and again as evening fell, on July 4 in Bristol, Rode Island. Philadelphia celebrated the first anniversary with an official dinner for the Continental Congress, toasts, 13-gun salutes, speeches, prayers, music, parades, troop reviews, and fireworks. Ships were decked with red, white, and blue bunting.
- ★ In 1778, George Washington marked July 4 with a double ration of rum for his soldiers and an artillery salute.
- ★ In 1781, the Massachusetts General Court became the first state legislature to recognize July 4 as a state celebration.
- ★ In 1791, the first recorded use of the name Independence Day occurred.
- ★ In 1870, the U.S. Congress made Independence Day an unpaid holiday for federal employees.
- ★ In 1938, Congress changed Independence Day to a paid holiday

According to the 1900 Encyclopedia Britannia July 4 is a legal holiday in all states. But it also lists many other anniversary holidays such as: January 8 in Louisiana for the anniversary of battle of New Orleans; March 2 in Texas for the anniversary of Texan independence; April 21 in Texas for the anniversary of the battle of San Jacinto; May 20 in North Carolina for the anniversary of the signing of the Mecklenburg declaration of independence; and August 16 in Vermont for the anniversary of the battle of Bennington. Lastly, it lists that every Saturday after twelve o'clock noon is a legal holiday in New York, New Jersey, Pennsylvania and Maryland. (No reason given).

Also listed was a curious (to me) old English holiday which had its origin in medieval times called the Mothering or Refreshment Sunday,


Mid-Lent Sunday, on which the old rural custom obtains of visiting one's parents with presents. —Karl Kuhn


