FROM THE HELM

HEADLANDS PUBLIC RESTROOM & VIEW BLOCKAGE MATTER SUMMARY AS OF JULY 15, 2008

SITUATION BACKGROUND

The Association first became aware of the potential view problem when the exact location of the public restroom & funicular buildings were discovered on the engineering drawings from South Coast Water District in relation to the Headlands/NSCA sewer line project on the beach bluff in November/December 2006. This discovery initiated a series of meetings with the Headlands management, the City of Dana Point and NSCA Board members that resulted in the Headlands management agreeing to redesign the buildings to reduce their view blockage impact but refusing to remove or relocate them.

The full extent of the View Blockage issue with the public restroom & funicular buildings did not become apparent until actual construction began in April 2008. The buildings conformed to the redesign agreement parameters, but as construction progressed, two new view blockage issues emerged: (1) the restroom landscaping that now included multiple tall pine trees and (2) a solid 6 foot

masonry privacy wall that would eliminate any southern white water view.

When confronted by our management, the Headlands and City of Dana Point refused to address these issues. As a result, the NSCA Board of Directors formed a special homeowner, Ad Hoc Committee, comprised of residents who specifically had prior experience in similar disputes with the city and developers. This group included a former Board President, a current Board member, our General Manager, and an Attorney who specialized in construction disputes.

As the situation developed the Ad Hoc Committee contacted: The Headlands, the Coastal Commission, The City of Dana Point and (2) law firms that have litigated against the Headlands and/or the Coastal Commission.

Their investigation into this matter produced an unexpected result after the Headlands management put up story poles that displayed the building envelope for the first beachfront lot south of Niguel Shores. It appears that this house represents the ultimate "view blockage" issue that may soon eclipse the problem with the pine trees and privacy wall. If built to the maximum approved envelope (represented by the story poles), the residence would block the southern view of the Headlands, as well as the white water view. Of course it is possible that this house may not be built to its maximum approved envelope. But if it is, the

FROM THE GM

66 TX TATCH DOG" OR "LAP DOG." - I attended a City Council meeting recently for a Headlands matter and, at that meeting, a homeowner (from a different HOA) went to the podium and accused the city of not fulfilling their duty as the public's "Watch Dog." Instead, he accused them of being the Headland's "Lap Dog." After reading John Dougherty's summation of the public restroom issue in this issue, it is easy to see why he might conclude the city's true pedigree. With this unfortunate experience behind us, I believe all we can do is go forward with an attitude that our lesson has been learned.

Here is something additional that we learned in the process and is well worth remembering. Niguel Shores has between 1400-1500 registered voters. It takes between 3000–5000 votes to elect a city councilman so, as a political block, we represent about 20%-40% of the necessary vote. We are also the largest HOA in south Orange County and if we can unify our voting voice, we can demonstrate that our views (pardon the pun) need to be carefully considered by the city of Dana Point. We can be far more powerful than any of us ever imagined. To make this power useful though, we must be vigilant of what the city is considering and who is sitting on the City Council. To this end I can commit that the NSCA staff will make every effort to identify critical issues and communicate them to the homeowners in time for our views to be heard by the city.

An excellent example of this is the "Surf Museum" that is being considered for the Sea Terrace Park (behind the library). The final decision on its location has not been made yet, but we have definite concerns over the specific location in the park and traffic patterns that will access it.

The Association is not fundamentally opposed to the museum, but definitely does not want to see it compromise the landscape aesthetics of the corner of PCH at Niguel Road. In addition, having the increased traffic enter off Mariner Drive would only compound the egress / ingress into Niguel Shores. The best solution would be for that traffic to enter off Stonehill. Since this project is still $4 \sim 8$ years away, we have the time to be involved.

DOGS (other) While on the subject of dogs, I received a letter from the Coastal Animal Services Authority asking the Association to remind homeowners that city and state regulations require all dogs over four months of age to have current rabies vaccination and a city dog license. The license enables officers to return your pet to you should your dog leave your property and become lost. You can license your pet at either the Sheriff Substation at the Dana Point City Hall on Golden Lantern or at the San Clemente/Dana Point Animal Shelter at 221 Avenida Fabricante, San Clemente, CA. trees and the wall become moot, with respect to the view blockage issue.

SUMMARY

The Headlands submitted their proposed development plan and the Dana Point Planning Commission and Dana Point City Council approved it in September 2004. The city approved plan was then submitted to the Coastal Commission, and they also approved the plan. When questioned about public access or view blockage issues, the Coastal Commission stated that their policies on these matters were fully considered before issuing the final approval, which was given on December 23, 2004.

After the Commission gives its final approval to a project, by law, the public has 90 days to make comments or register objections to the plan and public notice was given. We have not uncovered any evidence that the Public Notification process involved in the approval process of the overall Headlands Development Plan was violated. Niguel Shores did not raise any objections in the required time period; so unfortunately it is now three years later and too late to object.

While we have been stymied to date, we are hopeful that some additional avenues may mitigate the situation. For example:

- The City Manager has "verbally" stated that they will review the restroom landscaping and the 6' masonry privacy wall after they take ownership in 2009.
- Private individuals have filed formal American Disability Act (A.D.A.) violations with the Justice Department.
- The County has been advised of the ADA issues with the funicular and they are initiating action both at the county and the city for corrections. We have been advised that this may involve moving the restroom, or more likely it may result in the redesign of the path from the funicular down to the Strands Beach.

For the longer run, it is imperative that the Association stays vigilant in the City Council and community affairs of Dana Point because decisions made by the city may impact us in many direct and indirect ways. Please be assured that we will continue to strive to protect our community's interests.

ARCHITECTURE

Water, Water Everywhere – particularly, running in the rain gutters in the street. How can this be when we have not had any rain? Some water is inevitable due to our slopes and required sump pumps to drain flooded yards. We have a very high water table in Niguel Shores and do not need to water much. Over watering not only causes grief for our neighbors, but the water gushing into the street gutters carries pesticides, fertilizers, and animal waste directly into our already polluted ocean.

There are several websites with information on where to get rebates for weather-based irrigation controls, rotating nozzles which apply water more slowly and uniformly than conventional spray heads, and for synthetic turf. One site is www.conservationrebates.com/programs.mwd/outdoors .html. The website, www.bewaterwise.com suggests that you water before 8:00 a.m., install a smart sprinkler controller, use a broom for hardscaping, check for leaks on your sprinkler system, and mulch, mulch, mulch! tion, when replacing or relandscaping, consider native or drought tolerant plants, and naturescaping or xeriscaping. Www.bewaterwise.com also has an extensive plant database. And, the Architecture Committee has a list of recommended trees for our area.

For August and September, the city of Dana Point recommends watering no more than a total of 25 minutes per week. Set your irrigation timer for 3-4 minute cycles, which is probably sufficient. We are in a drought situation and will probably be facing water rationing in the future. Some parts of Northern California have had water rationing for more than 12 years. Do you want to have to decide between taking a shower and watering your roses? When I was living in Northern California, we replaced a perfectly good dishwasher and washing machine with water misers, which cost \$1,000 each, so that we could have some landscaping. Start being aware now!

FINANCE

The 2009 Budget process begins in July and runs through October of 2008. We will be reviewing the 2009 proposed dollar amounts relating to all the accounts: Traffic and Safety, Maintenance, Landscape, Architectural, G & A, Income, Recreation, Communications, and the Reserve Account for asset repair and replacement. Approximately 28 percent of our dues currently goes to the Reserve Account and 72 percent goes to the Daily Operating Budget.

A committee for construction oversight on the MPR Project has been recently formed and currently consists of Roy Dohner, Dave Ontiveros, Rob Rifkin, and myself -Marcy McNulty. Initial topics involving pre-demolition tasks, building demolition, electronic needs for the new building, temporary relocation of maintenance, and final interior material and designs are currently being discussed.

The first assessment payment of \$1500 per resident is due no later than August 31. Although actual demolition will not begin until January of 2009, we will begin incurring expenses in 2008 for items such as architectural fees and temporary relocation of maintenance and items in storage.

Separate line items to track the "MPR Assessment Income" and "MPR Expenses" will be established.

The new beach bluff parking lot and street asphalt/slurry project, estimated at a cost to Niguel Shores of approximately \$800,000, will begin in September of 2008 and will take about 9 weeks to complete.

As of June 30, 2008, our reserve account totaled approximately two million dollars. An additional \$66,250 will go into this account each month through December. The

\$800,000 asphalt project will come out of this account. These funds are always earning interest. They are invested in interest bearing checking and money market accounts and certificate of deposits.

LANDSCAPE

If you want to contact the landscape representative of your area about any landscape concern, contact the office or check the website at www.niguelshores.org for the Homeowner Request Form. When you fill out the request form and return it, your area representative will meet with Wendt and you to help solve the problem. The Landscape Committee is made up of representatives from each of the eight areas of Niguel Shores. These members walk their areas and look for problems that could be of concern. One of our concerns is not using the slopes by gardeners or children looking for a short cut home.

We are currently treating an infestation of thrips in our community. This infestation is evident from Ventura to San Diego County. We have seen some improvement in our slopes and Myoporum with the chemical spraying and will continue to monitor the problem.

This time of the year it is difficult to keep the dandelions and other weeds under control. Be sure you are not over watering. It is important that slopes are maintained and kept properly landscaped to avoid slippage and safe from injury to others. We still have our warmest months ahead of us. The Landscape Committee will also work with the View Preservation Committee on view concerns. A big thanks to Wendt for our very attractive gate entrances. The blue and white petunias that replaced our pansies are a very colorful sight. Be sure to take time to notice them as you drive through your gate.

MAINTENANCE

From time to time a resident will come forward to advise and consult the Maintenance Committee and staff on both large and small projects. A couple of current projects are street reconstruction and the parking lot stairway. The street/parking lot reconstruction and slurry seal project is scheduled to begin in October. This is a very large project, costing over a million dollars. We have an able staff and have hired an engineering firm to manage the project. We also need Maintenance Committee involvement. Two residents, Marcy McNulty, for finance, and Sam Johnson for construction have volunteered to join the project management team offering their time and expertise.

Maintenance is completing a project to put new hand rails and lighting on the beach parking lot stairway. The task involves making the stairway safe and attractive, without imposing light pollution on residents who have a view of this stairway. Werner Richter offered the use of his tools and wood working knowledge to make a more attractive stairway by concealing the wires necessary for the lights. Mr. Richter, by the way, is the person who, some years ago, made all the street signs seen throughout the community.

The Maintenance Committee welcomes resident help. It might be a million dollar project or how best to conceal a wire. to a garden. Choosing a tree or shrub should not be a hit or miss affair. Where it's planted, how it can be shaped and how it will affect your neighbor's view should all be considered. Some fast growing plants can be deceiving as to how they can quickly infringe on a view, yours or a neighbor's, because of their rapid growth. Coral trees are in this category, while other trees, such as hardwood trees, grow very slowly. It is much easier to live with slowgrowing trees and plants that require low maintenance.

It is wise to respect these habits in choosing shrubs and trees for your private yard. Select from the wide variety available those which fit naturally into your garden rather than those that must be forced and pruned into unnatural shapes.

Finance = Money = Us continued from page 1

Scott McCarter. The committee is assisted by Board Liaison, Todd Wallin, also a business entrepreneur.

This committee is responsible for preparation of the Annual Operating Budget which means it recommends to the Board what portion of our assessment monies are used to operate the community and, with the help of some professional advice, recommends what portion is deposited in our reserve account.

The Operating Budget is prepared at this time of year based on the presentation of the proposed needs of the various committees that are involved in areas of expenditure: landscape, maintenance, and security (Traffic & Safety Committee), and the proposed administrative needs as presented by the General Manager. As for other committees, Recreation is mostly self-supporting and Communication somewhat in the sale of advertisement for the newsletter. The committees must provide a line by line proposal of expenditures; the Finance Committee reviews these expenditures based upon a four to five year average (prepared by the controller, Ivy Hsia), takes into consideration inflationary increases, and recommends to the Board a total expenditure for the year. A major component of the total is administration employee costs (approximately 28 percent of the Operating Budget) which include salaries, Social Security payments, health insurance, and Workmen's Compensation. Other administrative costs include utilities and insurance. The Finance Committee looks at priorities, high risk areas, and considers when new bids should be obtained for various services to solicit competing costs. At the end of this process, the draft Operating Budget document is a three-column summary with one column representing the various committee requests, a second represents the Finance Committee's recommendation and the third to be determined by the Board as the final approved figures. Thus, the total Operating Budget for the year becomes a fixed amount. During the year, monthly reviews are made by the Finance Committee which studies variances within the many budgets. Variances occur when spending year-to-date is over or under by 10 percent and at least \$500. Reasons for variances are generally (1) timing of expenditures, (2) having to spend money on items not anticipated or included in the budget, and (3) anticipated expenses costing more or less than budgeted. If there is a need, the committee, the staff, and the Board work together to (a) determine where to cut future costs or (b) move planned spending to the following year.

So much for the Operating Budget. The second important responsibility of the Finance Committee is the determination of the assessment monies that are deposited into the reserve account. At present the community deposits \$800,000 per year of our assessment payments into the reserve account. The major assets covered by this money are the streets, building maintenance, pool and spa, fencing, street lighting, concrete sidewalks, stair wells and slopes. If an asset has a 20 year life and is supposed to be replaced in 10 years, then to be fully funded, we would have to have saved 50 percent of the replacement cost. The obligation of the community is to provide a reserve account, to track where it stands, and to provide this information to the residents. Communities are not legally obligated to be "fully funded." That is always a goal which can be met but is many times determined by rising costs, emergency expenditures and inflation. Every three years, professional reserve experts are hired to review all of the assets and reserve needs for the community. On an annual basis, an informal review is done with input from the maintenance staff, the Maintenance Committee, the board liaison to maintenance, the general manager and the Finance Committee. Generally, adjustments are made every three years and not made on an annual basis unless there is a very large increase in costs or it becomes obvious the life of an asset is significantly greater or less than anticipated. Every year, however, Controller Ivy Hsia does update the reserve account spreadsheet for inflation, factoring in 3 to 3.5 percent.

Now, who is responsible for investment of the \$800K that is annually deposited in the reserves? An Investment Sub-Committee of the Finance Committee is charged with the responsibility of recommending to the Board where and how to invest the money. This Sub-committee is chaired by Gretchen Letson-Rask who is assisted by Sue Kichline, Controller Ivy Hsia and Board Liaison, Todd Wallin. These members work with the controller to study major trends in investment, to track the interest rates and to search for the most advantageous areas of investment. The choices generally have been, in addition to the operating checking account, money markets, or certificates of deposit. There is something of a ballet that goes on in investing the reserves but also having cash available when needed. Gretchen says that lots of time is spent analyzing this subject and predicting how much will be needed and when. This Sub-committee will use its expertise to handle the special assessment funds which will be coming in during August and can be invested on a short-term basis until they are needed for construction. Let's hope that money makes more money... Isn't that what it's all about?

MEET YOUR NEIGHBOR

NUDGING 90. YRS NOT MPH

ur "Meet Your Neighbor" this month is Forrest Owen, Jr., already known to many in Niguel Shores and also by many in the southern Orange County area as a result of his many volunteer activities. As I reveal this man's life history you will be impressed, as I was, not only with his fascinating career but also with his commitment to giving back to his community.

Forrest was born in September 1918 in Philadelphia, PA but moved to Battle Creek, MI when he was in the third grade. During the early '30s, when Forrest was in high school, live radio was a big booming industry (like the internet now) and Forrest was captivated by it. This interest propelled him to work, in his senior year, as a janitor and part time radio announcer in a local Battle Creek radio station. However, while doing this radio show work and his school studies, he was also propelling through the water on his high school swim team and became the Michigan State High School champion in the 100-yard breaststroke.

Following high school he continued for a year as a part time announcer before entering Michigan State University. At MSU he pursued a Liberal Arts degree and was a student announcer for four years on the non-commercial college radio station WKAR. Student announcers not only announced but also wrote, directed and produced many live programs whether on news, sports, agriculture, or music. For 25 cents an hour for as many hours as he could get Forrest worked his way through college and graduated in 1941. After graduation, Forrest's career took off as an announcer on radio station WXYZ Detroit, where he did news, local shows, station breaks and commercials. WXYZ originated live shows such as The Green Hornet and The Lone Ranger.

Forrest's take-charge reputation had grown and there followed new jobs (and promotions) as a radio producer in Chicago, Hollywood, and New York. Another skill learned during this time was to be a loving husband and father when he married Mary Lee and then three lovely daughters would join the family.

During this period, he produced such live network shows as Quiz Kids (NBC), Lum 'n Abner (CBS), Curt Massey-Martha Tilton (CBS), and was agency producer for Queen for a Day (CBS), One Man's Family (NBC), and the Garry Moore Show (NBC) to name a few and he worked with such stars as Bob Hope, Jack Benny, Fred Allen, Groucho Marx, Jimmy Durante, Durward Kirby, and Mike

Wallace. Back in Hollywood in the mid-50s Forrest did fewer broadcasts and more account management.

Forrest was promoted to VP-Manager Hollywood and, in the 1960s, was asked to move back to Chicago where he became executive VP and then president for his agency. In 1966 his agency was acquired by the firm Interpublic. Forrest became Vice President-Manager of a larger national agency in Chicago, was next elected NY Director in 1975, and finally VP-Manager in Minneapolis, handling major national clients. He retired in 1975 with a consulting contract for the next eight years.

So in 1975, Forrest and Mary Lee looked for an ideal location to settle and enjoy their semi-retirement years. And where would that be? Niguel Shores, of course, with a view of the Pacific and their sailboat in Dana Point Harbor.

In the following years Forrest would do consulting work for various local companies that needed his skills in sales, market research, organization and especially



management. But Forrest was not the type of man to sit back and not be challenged by new opportunities. And here he found a new calling: volunteerism.

There now followed a string of local and even international volunteer assignments. First, Forrest joined the International Executive Service Corps (IESC) which is sponsored by the U.S. State Department and provides the services of retired professionals to go to third world countries to advise their young companies in the growth potential of capitalism. His first non-salaried service assignment which provided only travel and living expenses was to Riyadh, Saudi Arabia. The four months Forrest spent there involved local market research. Several years later, his next IESC assignment took Forrest and Mary Lee to Jakarta, Indonesia, working in advertising agency management.

Closer to home Forrest was president of the Men's Club in 1982–83 and later elected to the Board of Directors of NSCA, serving as President in 1985–86. Forrest also served many years on the Architectural Committee. His commu-

nity service did not stop there. He became a member of the Board of Directors and then Chairman of the Board of Trustees (Foundation) of the South Coast Medical Center. He was a member of the Traffic Commission and also the Economic Development Commission, for the new City of Dana Point. He was on the Board of Directors and later President of the Friends of the Dana Point Library and helped stop the El Toro Airport.

Forrest now enjoys traveling even though he and Mary Lee have traveled twice completely around the world. Sadly, after 57 years of marriage Mary Lee is no longer here to share in these new travel experiences. He continues to enjoy swimming, his thrice-weekly gym workouts, the Internet, music and drama events, and, yes, he still wants to travel.

In the coming month Forrest will celebrate, with all 25 members of his family, the big 90th birthday, a reunion he is most excited about. Please join me in wishing him the most joyous of birthdays and hope that he can blow out all 90 candles on his birthday cake.




