FROM THE GM

PROJECT UPDATES – By the time you are reading this article, we should be well underway on the Beach Bluff and asphalt maintenance projects. The new grassy bluff area and all the new paving should be completed by the first week in November. The approval process for the new MPR (Clubhouse) should be completed by this writing including the new “lower” roof line. The next step is completion of the bidding process and the selection of the contractor to perform the work. This should also be completed in the month of October and the target start for construction remains January 5, 2009.

NEW HOMEOWNER SERVICE PROGRAM: We have created a new position on the staff, entitled the Service & Compliance Coordinator. Jenny Mairena will be the contact person for all service requests and enforcement matters. She will coordinate all requests, route them to the appropriate provider and then follow up with a written letter to each homeowner upon completion of service or compliance. We began implementing this program in September and, as part of the new process, you can now file your service requests on-line rather than coming into the office. Go to the Association’s Website, Niguelshores.org, then to forms and click on Service Request. This should greatly enhance our service and follow up so please let me know your comments as you try the new system.

This will be a great opportunity to hear their views on many subjects that affect us, such as the public restroom location, Sea Terrace Park and view protection. ARCHITECTURE

Residential Development Standards

Residential development standards have been a hot topic in the press this summer. Various newspapers have reported on debates and disputes in the coastal communities arising from differing views on the efficacy of building larger homes on sites that once were dedicated to smaller single family dwellings.

Niguel Shores is no exception. In fact, from the perspective of the Architecture Committee, it sometimes seems that Niguel Shores is at the eye of the storm. Several homeowner proposals for larger homes are currently in various stages of the AC review process. In this environment it is important that the AC review process supports the views of the Association.

The AC has relied on the existing Architectural Regulations and Guidelines, which contain many general and neighborhood-specific rules on set-backs, height restrictions, and view protection. The Preliminary Plan Review process, and the Community Forum process, (whereby neighbors are notified of a proposed remodel, story poles are erected, and a forum is conducted to solicit the comments of concerned neighbors), have been very helpful to homeowners and to the AC.

A weakness in the process is that homeowners and their builders and architects incur design expenses for projects that will almost certainly meet significant neighbor resistance

once the story poles are up. To address this weakness the AC has developed a set of RESIDENTIAL DEVELOPMENT STANDARDS to augment the May 15, 2008 Architectural Regulations and Guidelines. These proposed RESIDENTIAL DEVELOPMENT STANDARDS, in the form of an easy reference grid chart, have been reviewed by the Niguel Shores board and distributed to all homeowners for consideration.

In developing these neighborhood-specific standards for all nine of the Niguel Shores neighborhoods, the AC relied upon sections in the Dana Point Zoning Code. The AC addressed "envelope size" which is a specification for the size of a proposed second story in relation to the size of the existing or proposed first story (in those neighborhoods that permit second stories). Maximum lot coverage is also addressed, and hardscape/softscape ratios are established for each neighborhood. The proposed RESIDENTIAL DEVELOPMENT STANDARDS are compatible with, though somewhat more stringent than the standards established by the Dana Point Zoning code, and should minimize confusion as to which standards to incorporate in design proposals.

The AC firmly believes these RESIDENTIAL DEVELOPMENT STANDARDS are necessary to promote harmony and consistency in Niguel Shores' continuing development. Please give them your careful consideration.

COMMUNITY CENTER

Renovation Update

Light at the end of the tunnel? It's been a long journey but the end is actually in sight. We've had six different Boards, four different volunteer committees, a multitude of community presentations, and a number of plans with resident suggestions driving numerous revisions plus two special assessment votes. Now, if all goes as planned, our six and one-half year journey should be completed during the summer of 2009.

Beginning in January 2003, the first team surveyed our community to assess our needs and develop a program. A number of similar upscale communities were surveyed to understand how they planned and paid for their common administrative and recreational facilities. Following a four-month selection process, an architect was hired, and plans were developed and presented to

the community. In response to feedback from residents, the original plans were revised a number of times until a consensus was reached. A vote to approve a special assessment of \$2,500 to construct both the office and community center was narrowly defeated.

Subsequently, the dues were increased, a second team was formed and the plans were revised once again, separating the office from the community center. A number of alternative architectural styles for the office were presented to the community with the residents overwhelmingly voting for the originally proposed style. Based on feedback, the height and profile were reduced to achieve a general consensus.

Once adequate funds were accumulated, the office construction began. Concurrently, a third team was formed to develop a plan to design and fund a future renovation of the community center. The interior design was presented and, based on member feedback, an

interior hallway and room divider were eliminated, saunas and family restrooms were added, outdoor showers were relocated and the lobby was reconfigured to accommodate a resident's lounge. Story poles were erected and, due to expressed view reduction concerns, the roofline was lowered and, once again, the design was revised.

Now we are awaiting a positive recommendation from the Architecture Committee, approval by the Board, and then if the good Lord's will'n and the creeks don't rise, the fourth team will begin the construction process.

FINANCE

Niguel Shores volunteers and staff are currently working on the 2009 budget, which will be finalized by the end of October. Our yearly dues maintain the entire community, including landscape, guards, pool/spa, fencing, electrical, buildings, and staff. We are like a small city with 960 homes and an estimated 2500 people.

It is not always easy to please a group of 2500. Some of you have not been pleased with the assessment for the new Multi-Purpose Building which the majority of homeowners passed in May, 2008. Others were happy to pay the

assessment and sent the entire \$3000 immediately.

Financially, the assessment was the best decision for the community. The old buildings were built in 1974 and lasted over 30 years. The new buildings should carry us forward for the next 30 to 40 years and our dues, barring an unknown catastrophe, will remain low, unlike many communities in southern California.

There are many of you who are original owners in Niguel Shores or who have lived here many years. There are others who just moved to Niguel Shores in recent years. The old-timers had the opportunity to use the old building for

many years. For newcomers, you will have the opportunity to use the new building for many years. So none of us should feel like we are paying for something we don't or didn't get to use. It will be the first thing our visitors see when they enter the community.

By 2010, we will have all new asphalt overlay on our streets, a new beach bluff parking lot, and all new buildings and our dues will not have to increase as a result of these improvement projects. Thank you in advance for your patience while we go through this major construction period.

LANDSCAPE

The Landscape Committee is comprised of eight members and a Board Liaison. Each member is assigned an area which includes Berkus, Broadmoor, Sea Terrace I, Sea Terrace II, Custom, Atlantic Garden, Shores Garden and Villas. All representatives are responsible for monitoring and recommending needed improvements in their areas. When homeowners have concerns, they may complete a Homeowner's Request. The request will be forwarded to The Landscape Committee. The homeowner will receive the Landscape Committee recommendation.

As our community matures, we are addressing landscape problems which were not taken into consideration when the community was originally landscaped. We are implementing both short-term and long-term plans to correct the problems, to be minimally invasive and costly. An example: over the years our slopes have become overgrown with a variety of plants

competing with each other. The slopes are being addressed, although it must be done on a long-term basis because of budget restrictions.

The entrance color plantings are being cleared and we will begin planting color in various entrances as the pansies become available. We received many compliments when pansies were planted last fall. We are continuing to spray our Myoporum that have thrip infestation and some areas are showing improvement. We would really appreciate residents and guests monitoring children and pets to prevent them from walking through the rose bushes at the beach bluff.

With fall season around the corner, everyone can adjust irrigations systems. Recently some homeowners experienced a brief power outage. Please remember to reset automatic timers when the power is restored. The City of Dana Point has some great tips on water conservation on its web site-- www.danapoint.org.

MAINTENANCE

It seldom rains in Southern California. So, why is there water in front of my driveway? The good news is that you live in a beautiful ocean side community. The bad news is that you live in a beautiful ocean side community with very poor drainage on many of our streets. Many of our streets were simply just not built with sufficient elevation drops to permit good drainage.

We have had our consulting Civil Engineer look at some of these streets. He tells us, to fix the problem we need to reconstruct the street. The estimated cost for just one street is \$200,000. We have many streets that would require a similar fix. Just in the garden homes there are

thirteen streets that could qualify for this type of repair. Obviously, reconstruction of our streets is not economically feasible.

But all is not lost. There are some things the maintenance staff can do to mitigate the problem. Sometimes we can grind high spots or cut grooves that will improve the flow. We can power wash if a buildup of dirt is causing blockage. If the asphalt is damaged we can patch and seal.

Probably the most effective thing we can do is to determine the source, and try reducing the flow of water onto the streets. In most cases the source is community or private irrigation systems. Maintenance staff can work with our landscape company and reduce

water runoff to the street. We can stop the water from going into the street. We can keep the grass and vegetation green. Doing both at the same time is a little more difficult.

Now, what can the residents do? First, know that if your irrigation water is running into the street it is probably going to stay there until it evaporates. So check your system and adjust the timers to where the grass stays green, but you don't run water into the street. You might also check the standing water and see if a little sweeping on your part would improve the situation.

In many cases the water is only going away when it evaporates. Fortunately we live in an arid climate which eliminates the concern of mosquitoes breeding in

our gutters. The mosquito life cycle from egg to adult is ten to fourteen days. Maintenance continued for days. Our puddles don't last that long. But puddles do come and go. Working together, maintenance staff, landscaping staff and residents, we can and will reduce the amount and length of time water stands in your gutter or in front of your neighbor's driveway.



GARDEN CLUB



Beware! The Garden Club will seduce you into membership by way of their great eating events,

and then it will expose you to all of the creepy, crawly monsters in your garden. Such was the theme of the meeting of September 15 under the tutelage of Linda Koppang and her husband, Jerry.

The most recent recruiting event was the beach bluff barbecue on July 21. There were 55 in attendance at seven tables. (We may have picked up a few new members.)

After introducing the other board members (Debbie Hanson, Membership; Karla Sanders, Treasurer; Janet

Mackaig, Secretary and Peter Rask, SSN Reporter) Linda launched into an expose of the insidious and numerous garden invaders plaguing all of the members.

The geraniums are being eaten by moth worms. However, they can be nicely controlled by the application of "Monterey Garden Insect Spray" available at most of the local garden stores. Tomato pests include skunks, moles, voles, rats, mice, raccoons and the ubiquitous thick, green, juicy monster worms which will eat a whole vine unless picked off by hand during a daily inspection. Skunk traps are available at the NS office, and Vector Control will help with some of the others.

Azaleas are being attacked by black mites against which Ladybugs can be deployed. The Rose Thrip is once again on the loose. When cutting off a rose, or when trimming the bush you are advised to apply a drop of Elmer's Glue

to the tip of each cut. (Did I hear that right?) Finally, we heard about combating snails with dishes of beer into which they can crawl and die (happy, no doubt).

Our community, as well as all of Southern California, is dealing with a new thrip pest that is damaging the Myoporum.

In addition to the web sites listed in last year's Yearbook, Jerry highly recommends the UC Davis web site known as www.ipm.ucdavis.edu/PGM/GARDEN/CONTROLS.

For those having trouble with raccoons Linda recommends keeping them out the house at all cost. One such animal made a pass through her house one day (or night) and she and Jerry are still cleaning up the mess.

Aaron Michelson is a senior at Dana Hills High School where he excels at his studies and enjoys more and more advanced computer classes—learning advanced commands, studies the operating systems and speaks a language that only his ilk could understand. You may have seen his ad in the SSN offering to work on your computers to earn some extra money so he can add more drives and ram and whatever to his computer as well as his game console. Aaron plans to pursue Video Game Design as a career and speaks with great knowledge on this subject. 

HEADLANDS DEVELOPMENT

Excerpt from L.A. Times – 9/18/08

After more than 30 years of legal, legislative and environmental battles, the multimillion-dollar development on the Dana Point Headlands was unveiled in a coming-out party Wednesday afternoon (9/17/08).

Eventually, the 121-acre project will have 118 ocean-view homes... plus five parks, a 90-room hotel and spa and a 35,000 square-foot shopping center.

Just 15 or so homes are under construction at the site where grassy 9,000 to 10,000 square-foot parcels are selling for as much as \$12.5 million for the land alone. Although the average sale price has been half that, the \$12.5 million deal broke Orange County records. Once buyers own the dirt, the houses—with such luxurious touches as infinity pools, home theaters and eight-car garages—can cost \$10 million more.

To make way for the houses, developers completely leveled the original outcropping... and reshaped 2 million cubic yards of earth into the terraced lots of the Strand at Headlands. The land is supported by extensive retaining walls of concrete blocks. Headlands Reserve is building a \$2 million motorized rail car system to move people up and down the bluff, in addition to public restrooms. Visitors can also take one of three new stairways or trails to the beach. A new public sidewalk runs 2,200 feet along the length of the development just below a green metal fence where each front-row lot has its own built-in beach access. More than 30 of the parcels have been sold, but only a portion have been put on the market. While the land has been selling more slowly than last year, the lots are more expensive than ever. Developer Sanford Edward said the best corner lot with the widest stretch of shore will probably sell for \$18 million. Buyers come from as far away as Australia and the majority will live here full time.

two of them, edits the articles for all three as well as being a long-time member of the Landscape Committee and carries some responsibility for its article as well. George Traver is editor for the Traffic & Safety Committee, the Landscape Committee and the View Preservation Committee of which he is a member and for which he writes and/or edits its articles. Kathy Jones, our Board Liaison, is a professional editor, past editor of the *Seashore News*, a welcome addition to our committee and the perfect person to ask for advice on all aspects of our newsletter publishing responsibilities.

As the editor, I receive and sign off on all of the articles, usually about thirty or so each month plus those that the staff provides: the calendar, directory, business ads, index, neighborhood ads and voice of the people letters. The editor is responsible for the Helm, GM report, Board Actions, the Community News page, some special articles such as "Meet Your Neighbor," the photo contest, etc., and often the feature article which is on the front page. All of these articles are then forwarded to the production person (formerly Mary McGavic and, starting this month, Kathleen Capalla in-house) for the usual juggling to fit them into the required number of pages. If there is an overage, the editor must remove or shorten articles, if there are empty spaces, the editor provides fillers—sometimes the fun and frivolous part. In this process, one hopes for a certain style and attractive design in the composition. I think this has been accomplished by the talented Mary McGavic in the issues that she has prepared over the past couple of years. There is an intense two or three-day period in this final process to get in last minute articles, fit them in and get it all to the printer in time to have the newsletter on your doorstep on the first of each month.

One sometimes wonders how it all happens. It seems like it should be easy which, in a way, it is. But, at the same time a huge responsibility for all of us. This newsletter has to be there on the first of every month! We do that, we enjoy it and we are pleased that people tell us it is interesting, that they read it, that they look forward to it and, as one candid young man told me, after two or three days, we throw it away! So be it.


