



DON'T FORGET TO VOTE*

In March and April, I had the opportunity to speak to the Mens Club and Womens Club about the *State of the Association*. My presentation was entitled "Transitions."

A generational transition is occurring at Niguel Shores. I characterized the generations as those born before 1941 and those born after. The pre-1941 generation was influenced by the economic Depression, the national unity that resulted from the Second World War, and a willingness to follow the rules. The post-1941 generation was influenced by economic prosperity, the emphasis on individual rights, and a tendency to question the rules. While

these generational experiences are a simplification, the pre- and post-1941 generations do have attitudinal differences which can create intergenerational tensions.

An analysis of the Mens Club roster indicates that only ten percent of the members are in the post-1941 generation. While I am sure the general population of Niguel Shores has more post-1941 homeowner families, I am equally confident that over the next ten years the Shores population of the post-1941 generation will significantly exceed 50 percent. How can we know this? Insurance company actuarial tables never lie.

This generational transition is already being reflected in some of the following ways:

- increasing participation of the post-1941 generation in our volunteer regular committees, ad-hoc committees and the Board of Directors,

- proposing new activities to address the needs of the total Niguel Shores community,

- being more sensitive to rule enforcement and quicker response to homeowner concerns,

- and communicating more effectively, particularly through the use of our Web site and e-mail.

37 YEARS – WE MUST BE DOING SOMETHING RIGHT!

In the beginning there was a developer. AVCO of Greenwich, Connecticut owned most of the land from Interstate 5 to the ocean and that property was known as Laguna Niguel. By 1969, AVCO was building a planned community called Niguel Shores. Crown Valley Parkway existed, but there was no Niguel Road inland. Access from the freeway was via Crown Valley and from Laguna Beach or San Clemente. We came via Coast Highway. Key to our new development, which did not sell well at first, was a bridge AVCO built across Coast Highway. Beach access!

Niguel Shores was incorporated in 1969, with Architectural Regulations and Guidelines in place as provided for in the original CC&Rs (Covenants, Conditions and Restrictions). Development was not yet complete. Privatizing our streets and adding the villas was yet to come. In 1974 AVCO turned over ownership of the Niguel Shores Community Association to the residents while retaining two seats on our Board of Directors for a brief

period. Breakers Isle was in their plan but no houses were there until two speculative houses were built in 1975. Many custom home lots were for sale. Sales of every type

FROM THE GM

As usual, there is much to talk about this month. First, it is amazing that the new office building has taken shape so quickly that we can all begin to see what it will eventually look like. The contractor is doing a great job keeping on schedule, and we plan on occupancy in early July. We apologize for any inconvenience during this and other projects but, it is an unfortunate by-product of the construction process as we improve and maintain our Association amenities.

WE NEED YOUR VOTE! During the week of April 9 you should have received your ballot and voting instructions for the 2007 Annual Meeting and election on Tuesday, May 15. I want to remind you how important it is for you to cast your vote. We need **50 percent plus one** (or 481 ballots) to make a quorum and hold the election. The voting process has changed considerably this year as mandated by the State of California. If you find the new process confusing or difficult, please contact the NSCA office and the staff will be more than willing to help you through this process.

BEACH BLUFF CONSTRUCTION – We finally have a start date from the South Coast Water District on the sewer project that will run across our Bluff parking lot. The first phase of this work will start on Monday, April 30 and is planned to be completed by Friday, May 25. There will be no further work on the Bluff during the summer but phase two will begin during the week after the Labor Day holiday. This phase will involve the Bluff parking lot and Magellan

Drive. (Please see the Maintenance article for additional information.)

CAUTION – during the month of May, there will be heavy equipment transiting Niguel Shores Drive for this Bluff project, so please drive carefully and watch for any flag men or traffic control signs. Lastly, to try and minimize this disruption, the construction activity will be limited to Monday through Friday from 7:30 am through 4:30 pm.

CAMP HOBBELDEHOY – The fact that summer is just around the corner means that Camp Hobbledehoy is back. This year the camp starts Monday, June 25 and runs through Friday, August 24. For those wishing to sign up their children, contact Ryan, Peter, or Craig at 949 489-3447.

NSCA STAFF CHANGES – Unfortunately, we have lost Catheryn BeVier because of health issues but, we were fortunate enough to be able to promote Melanie Jenkins from her part-time clerk position to full-time staff position. In addition, we have reviewed the job descriptions for the positions that both Melanie and Bobby Gargari hold, and have changed their titles to more accurately reflect their responsibilities and duties. The new title for both these positions will become **MEMBER SERVICES REPRESENTATIVE**. In addition, to be consistent with this change, Karen Decker's position will become **MEMBER SERVICES MANAGER** and these changes became effective immediately.

OFFICE PROGRESS

The new office building is right on schedule for completion by the first week of July despite having a two-week delayed start occasioned by new found permit requirements by various levels of government. The site is now graded with practically all the unseen underground utility supply requirements completed and ready for later connection. Framing is finished and much basic electrical and plumbing work within the building complete.

During the month exterior stucco will be applied and the final metal roofing installed. The shoulder-high exterior rock facing will be underway. Ongoing interior work will begin in earnest as insulation, wiring, plumbing, and sheet rock work progresses. By month's end the building should be secured and ready for the detail work within.

Workmanship and materials used to date have been outstanding thanks to the careful selection process of our contractor, helped in no small part by the Board, the staff, the outgoing revitalization team and our architect. We are getting a real quality building, well suited to our needs which should last the community for decades to come.

ENTRANCE/EXIT GATES—

A WORD OF CAUTION FROM TRAFFIC & SAFETY ABOUT TIRE DAMAGE

One vehicle at a time: If you approach one of the entrance/exit gates in the community and you see that the wrought iron swing gate is open or in the process of closing, you should wait outside the gate until the gate has recycled. **Our gates are designed to operate with only one car per cycle.** If you enter too soon, you risk going over the security teeth and then find yourself trapped if the gate suddenly closes in its recycle process. Be patient, “Just Slow Down” and in the end, you will save yourself time and trouble.

Towed vehicles: Security cameras at the “resident only” gates have recorded instances where residents have

attempted to enter **pulling a trailer only to have the security teeth come up and damage the trailer tires.** The sensors in the street are designed to start the gate closing process after the passing of the car’s rear tires so, by the time the trailer tires pass, the teeth are up. Another case involved a large moving van entering a resident only gate causing substantial damage to the gate.

The guest lane at Mariner Drive has no teeth in the road and is extra wide to accommodate trailers and trucks of all sizes. Please enter there with your towed vehicles and instruct others to do the same. (*See Traffic & Safety article under Committees for further information.*)

of new home increased as our family-oriented planned community began.

In 1973, a CC&R committee of residents existed, but not until 1976 was a separate Architectural Control Committee activated with Bob Chandler as Chair. By then our Home Owners Association board had decided to operate with a small staff plus committees of volunteers instead of hiring a property management company to run the place. Economies resulting from these decisions have kept our annual assessment fees well below those charged by other large associations. An unseen dividend has been an active and enthusiastic community led by volunteers. Yet, in those early days, when homeowner associations were relatively new, there was often little knowledge of the rules and regulations owners had agreed to. So, the small staff and our committee sometimes were unable to enforce relatively unfamiliar requirements. Some old timers may remember being handed a bunch of R&R or CC&R papers by a realtor at escrow, only to carefully file them away to read “later”.

Fortunately, all through the ’70s, our committee learned to work within

our system while adjusting to the ever-changing needs of our fast-growing community. During the ’80s, the volume of work increased substantially as property values boomed. Increasing concern about view blockage issues resulted in establishment of a very active sub-committee of the Architecture Committee called Tree View Blockage (now known as View Preservation). In 1988, resident Lee Richards chaired the AC Committee and continued to handle that burdensome job for seven more years. Lee continues to live in the Shores and we are grateful for her diligent and intelligent service. Then in 1995, George Williams took over what had become almost a full-time job and remained as chair for the next six years, until his untimely death. His wife, Mary, still lives here and we remember, with gratitude, his hard work and obsession to improve our homes. The volume of AC work surged with the remodel market. Since 2002 no one member was able or willing to undertake the difficult job as chair, so we have used a rotating chair system. Finally, just last month, Ginny Nevitt and Jerry Koppang volunteered to become co-chairs,

providing us with improved continuity and efficiency.

Today more than 50 per cent of our original homes have been renovated. Our property values have escalated. We now use a professional architect on a case by case basis as needed and our professional office staff is the best we have known. Many new owners are young with positive new ideas. Renovation, remodel, repair, even tear-downs and new construction continue. Of course, our need for professional legal advice also continues. Each year our Rules and Regulations are upgraded and improved to meet changing needs. We continue to be a standing committee of the Niguel Shores Board of Directors, to whom appeals may be made. Our community standards remain firmly in place.

We are, as we began, volunteers from many former disciplines, who continue to observe and enforce the Rules and Regulations of Niguel Shores to the best of our ability while assisting property owners to improve the value of their property. We thank you for your continued help in our endeavors.

FINANCE COMMITTEE

The Niguel Shores budget consists of three sources of **income**: (1) homeowner dues, (2) bank interest, and (3) fees and fines. The only income taxed is bank interest.

Our two categories of cost are: (1) **operating costs** such as landscaping, guard services and association staff, (2) **reserve fund/costs** involving capital assets. Historically, street surfacing has been our most expensive item.

Reserve funds have always been set aside each year for the repair and maintenance of the office building and the multi-purpose room; however, funds were not set aside for “total replacement” as this was not anticipated in earlier years.

Beginning in 2004, funds were set aside each year for a major renovation of the entire Community Center. It is anticipated at least \$900,000 will be in the building fund by the end of 2007, which is sufficient to pay for the new office building under construction. However, funds must now be set aside for a major renovation of the multi-purpose room.

At the beginning of 2006, all reserve line items, including street resurfacing, were fully funded at the forecasted cost. Unfortunately, what was not anticipated was the ever increasing cost of asphalt. In addition, the cost to divert surface water into city sewers and the cost to replace the parking lot retaining walls were not specifically included as reserve line items.

Current forecast of the accumulation of reserves indicate no problem by year-end 2007 or by year-end 2010 when additional reserves have been accumulated and major infrastructure investments have been made. The short-term dilemma is whether to spend the reserves below a comfortable level in 2008 and 2009, or to defer the MPR renovation or the street resurfacing project until the additional reserves have been accumulated.

MAINTENANCE COMMITTEE

A new dual-beam laser bar code reader has been installed at the Mariner gate. It is a tremendous improvement, but not perfect. All of the gate readers will work best if the driver will wait for the arm to come down and then drive 3 to 6 feet from the reader. South Coast Water District will soon begin work on the second level of the Beach Bluff parking lot. The entire construction project involves Niguel Shores Drive, Magellan Isle, and a portion of Breakers Isle and will not be complete until May 2008. The good news is, instead of a 10-foot trench, they will drill under the bluff access road leaving the road open during the entire construction project. Also agreed is to not work during the months of June, July and August. As a result there should be no impact on our use of the Bluff Park this summer.

Tree roots continue to cause hazards on some of our sidewalks. Three locations have been identified where the damage is sufficient to require removing the roots and replacing the concrete. Cost of these repairs will be about \$2,400, but are necessary to keep our sidewalks as safe as possible. Also, thanks to Bob Gregg for the gift of a radial saw for the Maintenance Department.

TRAFFIC AND SAFETY COMMITTEE

Golf Carts. The operation of a golf cart is covered by Rule 6431.

- Carts driven on streets in Niguel Shores are subject to the California Vehicle Code.
- Cart drivers MUST have a valid drivers license.
- The cart should carry only the number of passengers recommended by the manufacturer.
- It is illegal to tow a person(s) behind or along side a cart.

Bar Code Decals: If you are regularly experiencing difficulty in entering one of the gates, the problem may not be the bar code reader, but the decal on your car. If you have one of the "original" all black decals, serial 1 to 500 or a black and white decal, you should exchange it for a new one.

Red Cones: If you are wondering about the red cones by the side of the road at the Mariner Drive resident lane, they are an attempt to slow down and direct cars closer to the bar code reader to improve the gate efficiency.

Heliotrope will provide a lovely fragrance, and pentas will provide clusters of star-shaped flowers in shades of red, pink, lilac or white.

Take care to control rose slugs, the larvae of the sawfly, which feed on rose leaves, creating a skeletonized appearance. Happy gardening!

COME FOR TENNIS


Ladies tennis on Thursday has not been very active. We have had between four and seven people playing.


