BOARD ACTIONS



- ▶ The Board approved the formation of an Niguel Shores swim team under the direction of Cynthia Carlson.
- ▶ Approved a proposal from Borders & Associates to consolidate professional reports assessing the identified problems with the Community Center buildings and required code updates.
- ▶ Reviewed progress on the Community Center revitalization project.
- ▶ Conferred with legal counsel on legal and litigation issues, conducted several hearings and imposed fines.
- ▶ Approved the Association's 2004 tax returns for filing.
- ▶ Provided input (at the City of Dana Point's request) with regard to planting suggestions for the Niguel Road median strip.
- ▶ Reviewed the Converse Ground Water Mitigation report and directed the maintenance manager to seek bids to correct the identified problems.

ARCHITECTURAL CONTROL COMMITTEE

In order to ensure a prompt resolution to improvement requests owners are reminded to review *Rules and Regulations 3118, Applications for Associations and 3120*, and *Final Plans Submittal* and the rules regarding the easements and setbacks that apply to their particular tracts before submitting requests. These rules spell out the requirements necessary for a complete plan. Many incomplete plans come in and the committee has to ask for further information before a decision can be made. There is a checklist accompanying the improvement application which is helpful for properly completing the form.

Some of the most frequent mistakes are plans that do not indicate the location of new improvements vis-à-vis adjacent properties, property boundary lines, zero lot lines and, where applicable, top of slope. *Rules 3118 – 2b* and *3120 – 3a, b, c*, explain what is needed on the plan, and the setback/easement rules of individual tracts spell out specific requirements. It is important that plans clearly note the placement of new improvements vis-à-vis these boundary areas with proper measurements before final decisions are made.

COMMUNITY CENTER REVITALIZATION TEAM

The Board has established a new project team to investigate and recommend what must be done to the Community Center. Board member, Don Johnston, was chosen to lead the team. The initial direction has been to get professional evaluation of the many facets which make up existing structures (electrical, plumbing, structural, etc.) These evaluations have been turned over to a consultant skilled in building and code requirements to consolidate the various identified deficiencies and provide a detailed cost analysis of what will be required to bring the existing plant to proper, code compliant, safe structures. The detailed report is due during the final week of August. After

obtaining reliable true costs, the direction of revitalization will be set in motion. NSCA members will be fully advised and feedback is solicited.

Activity thus far has been directed to correction of previously identified high hazard conditions. Completion of phase one of the revitalization process included moving the pool equipment room out of the building and rehabilitating the pool

Much work is ahead with public hearings planned and input from all the community carefully evaluated. Recommendations will be sent to the Board for whatever develops through the process.

The team invites interested NSCA members to provide analytical, design, and communication assistance. Interested members should leave a written request for joining the team at the office as soon as possible. Residents are welcome to participate.

LANDSCAPE COMMITTEE

Please do not plant ivy or trailing *ficus* on walls of houses, garages or fences. They are invasive plants that grow into cracks and roofs, and they also spread into neighbors yards.

Some of the *podocarpus* trees planted on the Beach Bluff look like they are dying. It is not for lack of water. They are expected to become healthier as they adjust to the salt air. Removing brown branches from their trunks would increase their stress.

Weeds have been more prolific this year because of the amount of rain. The gardeners are removing weeds by the roots and applying pre-emergent to stop seeds from germinating.

TRAFFIC AND SAFETY COMMITTEE

If you are wondering why the gates at Selva and Cabrillo Isle are frequently out of order, security cameras have picked up juveniles attempting to, and in some cases succeeding in, disabling the inbound teeth and or the exit gate. Not only is this an inconvenience but it is an expensive repair. If you have any information regarding these senseless acts, please contact the office. We need your help.

Dogs OFF the Leash: We continue to get reports that dogs are being allowed off the leash in the community and often intimidate those walking nearby. Unless an *incident report* is filled out, no follow-up action can be taken. Firsthand information is needed. These reports are confidential. Get a form and fill it out. Everyone benefits from your effort.

VOICE OF THE PEOPLE

Letters are welcome and limited to 200 words, typed if possible, including name, address and phone number of writer. Refer to NSCA Rule #5221,2,3. Submissions are due on the 17th of the month except in Feb., Nov., and Dec. when due on the 15th of the month.

There have been several complaints and serious concerns about the towing of cars late at night from

Niguel Shores. In one case the vehicle towed had received no warnings and the pass was plainly in sight on the passenger seat. When the vehicle was picked up at the storage yard, the pass had been neatly placed in the glove box – out of sight!

I believe that we need to reform our regulations regarding warnings (according to our regulations NO warnings need be given before a vehicle is towed) and the authorization of towing. Right now the authorization is from a non-Niguel Shores service. They may have an agenda of their own when it comes to towing. For example, the vehicle parked next to the one mentioned above had two warnings and was not towed.

I have two concerns regarding the recent changes in security practices, in bypassing and passes.

The main gate officers frequently hit the bypass button for residents to save us a few seconds. How many of us have sold vehicles without removing our barcodes because we knew they'd be inactivated by the system? Many other communities use the barcode entrance system. One of those cars could be let in by the bypassing officers. This is a disturbing security lapse.

Another concern is with the new guest pass system. They don't expire. EVER! I was told that this was the replacement for the No-Call list. When I removed someone from my No-Call list they could not gain entry after their current one-day pass expired. Now, if I remove someone, they can keep their pass. My guest was given a pass that is valid for entry between 4/23/2002 _ indefinite ("indefinate" is spelled wrong on the passes, by the way). In bold capital letters the pass states "PASS DOES NOT EXPIRE AUTOMATICALLY."

I look forward to hearing if the Board of Directors intends to address these concerns.

The Cabrillo Isle gate is the worst. It is juxtaposed to the very elegant, simple, and classy Ritz Carlton sign. We have NINE signs. Four signs of warnings, two signs about this being private property, two signs stating "Residents Only" and last, but not least, a "Sorry" sign because the pedestrian gate on the west side is closed. Of these nine signs: five are

Occasionally these fumes occur in the morning hours as well. The smell has been described as acrid, acidic, chemical-based or even food-based. The fumes are most evident inside our homes where a breeze would not dissipate the odor, coming in through vents, chimneys, or open windows.

For some it causes burning and watering eyes, sore throat, and upper respiratory problems leading to cough, labored breathing, sinus congestion, low grade fever or headaches.

The odor occurs during all seasons of the year. Most of the complains have come from residents who live in the upper levels of Sea Terrace I & II, and the Berkus Homes.
