Completed applications and all fees must be submitted to and received by the NSCA office no later than Monday, December 2nd.

- Market Date: Sunday, December 8, 2024
- Market Hours: 12 p.m. until 4 p.m.
- Setup Time: 9:30 a.m. to 11:45 a.m. in the designated market area in the guest Beach Bluff parking tier. **MUST** be done before 12 p.m., **No Exceptions.**
- Fees: \$20 for one space
- Electrical: You are responsible to bring your own cords and all electrical cords **MUST** be taped down.
- Telephone Connections: There will be **NO** telephones lines available at the market.
- Tablecloths: You are responsible for your own. Table coverings are required and must be long enough to conceal any items stored under your tables.
- Teardown: Sunday, December 8th

- All vendors are to remain on site during market hours.
- The Niguel Shores Community Association and its Recreation Committee members reserve the right to refuse any vendor's application or to limit the sale of certain items if the wares are believed to be inappropriate to the spirit of a family-oriented market.
