## FROM THE HELM

I'm really excited to share some great news with you—our community is getting a major security upgrade! The Board has approved the implementation of **GoAccess**, a state-of-the-art visitor management and access control system. This is an upgrade Niguel Shores has needed for a long time, and I'm glad to see it finally coming to fruition.

A special thanks to our General Manager, John Muller, who played a major role in bringing GoAccess to our community. His leadership and dedication to improving security and efficiency in Niguel Shores were instrumental in making this happen.

GoAccess will enhance security and streamline entry for residents, guests, and service providers. The system features automated visitor check-in with AI-driven license plate recognition, reducing wait times at the gate. Residents will have access to a user-friendly mobile app to manage guest lists and amenity access. While the new system offers a convenient digital option, we will still retain our existing physical key fobs for those who prefer them. Additionally, our community management team will have better oversight with advanced reporting tools to monitor visitor patterns.

This upgrade is a significant step forward in keeping Niguel Shores secure while making daily life more convenient for all of us. I appreciate the Board's support in making this happen, and I look forward to seeing it in action soon!

As we move into March, signs of spring are all around us. The days are getting longer, the temperatures are warming up, and our beautiful community is buzzing with activity.

With this change of season comes an opportunity to reflect on the ways we can continue making Niguel Shores a vibrant and welcoming place for all.

One of the key responsibilities of our HOA is ensuring that our community remains well-maintained, secure, and enjoyable for residents. This means not only staying on top of ongoing projects like landscape enhancements and infrastructure maintenance but also fostering a strong sense of neighborly connection. Whether it's through community events, volunteer opportunities, or just a friendly wave to a neighbor, each of us plays a role in keeping Niguel Shores special.

This time of year also brings an annual ritual that affects our daily lives—Daylight Saving Time (DST). On Sunday, March 9, we'll "spring forward" by setting our clocks ahead one hour. While this change gives us more evening daylight, it also sparks debate every year about whether it's still necessary.

A little history: Daylight Saving Time was first introduced in the U.S. during World War I to conserve energy. California adopted DST in 1949 with the passage of Proposition 12, and we've been adjusting our clocks ever since. In 2018, voters overwhelmingly approved Proposition 7, which gave the state legislature the authority to make DST permanent. However, federal approval is required for such a change, and so far, that hasn't happened. For now, we'll continue the tradition—so don't forget to set your clocks forward and enjoy the longer evenings! Wishing you all a wonderful start to spring in Niguel Shores.

# GENERAL MANAGER'S REPORT

**Upgrades for 2025**—At the February 12, 2025 Board meeting, the Board approved a major upgrade to the association's access control system. We will be replacing Dwelling Live with **GoAccess**. This upgrade will bring new features, including a smartphone app that allows you to create and send guest passes directly from your phone to your guests. The pass will have a QR code printed, allowing your guests to enter the property at any of the NSCA gates without needing to go to the Mariner gate to get the pass. The computer interface will also be more intuitive and user-friendly. Barcodes will be replaced with a small RDIF reader placed on your windshield; if you have a Fast Track account, their transponder uses the same technology. In addition to these upgrades, the Board also approved the installation of license plate reading cameras at all the NSCA entries. This AI-based technology allows the Association to capture the license of each car entering the community. With this new technology, there will also be some changes in the rules regarding access. We anticipate the rollout to begin in the next 60 days. More information will be provided as we implement the systems.

**SCWD Annual Inspections**—South Coast Water District (SCWD), in collaboration with the community's landscape contractor, Harvest Landscape, will be

conducting the NSCA annual recycled irrigation water inspection starting February 24, 2025. Inspections will occur weekly on Mondays and Tuesdays and continue through June 2025. During this time, SCWD and Harvest Landscape will be inspecting all NSCA common landscape areas to ensure the system's efficiency and compliance with regulations.

Additionally, we would like to remind residents that the NSCA irrigation system utilizes recycled water, which is strictly regulated. As such, making unauthorized modifications or connections to the HOA's recycled irrigation water system is prohibited.

If you have any questions or concerns, please contact the NSCA property management office, attention Matt Northop.

**OCFA**—Management and Harvest Landscape met with Orange County Fire Authority (OCFA) to inspect the condition of the common slope plant material as it pertains to fire

prevention. Officer Martinez commented that the interior slopes meet the standard OCFA set: the plant material should be no taller than 2 feet above the slope. When we inspected the perimeter slopes, he noted some areas that needed to be addressed. These areas were allowed to get overgrown at the request of nearby residents trying to

## PAGE TURNERS

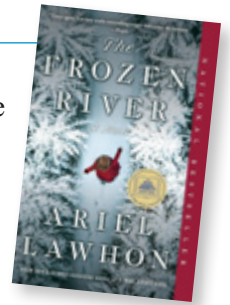

A horrific rape and subsequent murder take place, and Martha is called to testify in court as to her knowledge of the events. 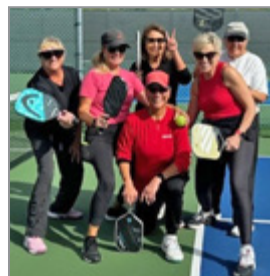

## FYI — SAFETY FIRST—FINANCIAL PROTECTIONS

**RFID Theft**—Have you heard about wrapping your credit cards in aluminum foil to protect against Radio Frequency Identification (RFID) theft? In reality, the threat from “Touchless Pickpocketing” is not as big as we’ve been led to believe. Contactless credit and bank cards use RFID technology, but a thief would have to be almost hugging you to electronically skim anything from your purse or wallet. Most cards now have encryption and dynamic codes that change with each transaction, so even if someone did snag some data, it wouldn't do them much good.

**Unauthorized Charges**—When thinking of credit or debit card transactions, something you should consider is that when it comes to unauthorized charges, credit cards and debit cards don't always offer the same level of protection. With debit cards, as opposed to credit cards, your required time to report a problem can be fairly short and your liability can be much greater!

Below is a brief comparison of the common differences between credit and debit cards in liability and resolution of a claim:

FEATURE	CREDIT CARD	DEBIT CARD
<b>Personal Liability for Unauthorized Charges</b>	Up to \$50 (usually waived to \$0 by issuers)	\$50 if reported within 2 days; up to \$500 within 60 days; unlimited after 60 days
<b>Impact on Bank Account</b>	No immediate effect	Funds withdrawn directly from your account
<b>Dispute Process</b>	Charges can be withheld during investigation	Funds may be unavailable during investigation
<b>Time to Resolve</b>	Generally faster	Can take much longer

**Mobile Options**—Many of us are now using mobile payment platforms like **Apple Pay** or **Google Pay**. Because these are newer, there is some worry about their safety, but they actually add an extra layer of security through **tokenization**. In this process, your real card number isn't used



during transactions. It's like giving potential scammers a fake address—they can't reach or copy your real info. Also, it's convenient just carrying your phone to make payments instead of a wallet full of cards. You can also use a digital wallet application on your phone to store your driver's license, insurance cards, ticket purchases and much more.

**Account Alerts**—Setting up account alerts can be a positive game changer. Take advantage of features most banks now offer like real-time fraud monitoring and alerts that allow you to receive notifications for transactions over a set dollar amount, or even for all your card purchases. Some banks even offer zero liability guarantees similar to those from credit cards. It's worth checking with your financial institution to see what level of protection they provide, and taking the time to set up your own alerts which can be done in minutes online.

**Passwords**—Technology evolves and so must the ways we protect our information. Biometrics like fingerprints and face scans are becoming our new passwords, but until they are more widespread our next goal should be to avoid written lists and eliminate the tempting but dangerous use of a single password for multiple accounts. Consider using a password application instead to create and store your passwords. Google Password Manager and Proton Pass are two password apps highly recommended by financial institutions, and both are free.

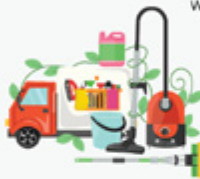

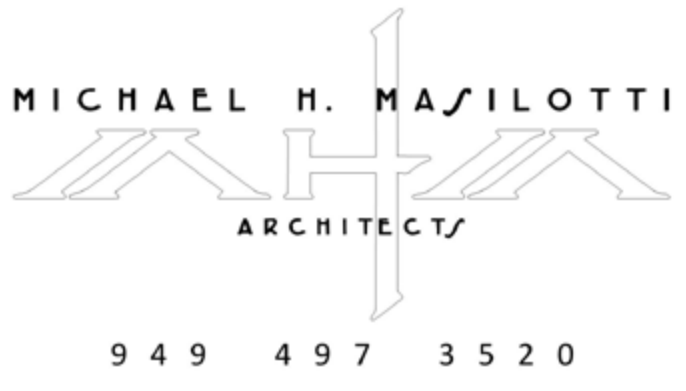

# MARKET UPDATE



## ACTIVE LISTINGS

The active listing inventory in the past couple of weeks increased by 212 homes, up 8%, and now sits at 3,033. In January, 17% fewer homes came on the market compared to the 3-year average before COVID, 528 less. Yet, 473 more sellers came on the market this January compared to January 2024.



## DEMAND

Demand, the number of pending sales over the prior month, surged by 157 pending sales in the past two weeks, up 12%, and now totals 1,497, its highest level since October. Last year, there were 1,397 pending sales, 7% less. The 3-year average before COVID (2017 to 2019) was 2,393, or 60% more.



## EXPECTED MARKET TIME

With demand rising faster than supply, the Expected Market Time, the number of days to sell all Orange County listings at the current buying pace, decreased from 63 to 61 days in the past couple of weeks. Last year, it was 42 days, noticeably faster than today.



## CLOSED SALES

There were 1,268 closed residential resales in January, up 7% compared to January 2024's 1,182 and down 22% from December 2024. The sales-to-list price ratio was 99.14% for Orange County. Short sales accounted for 0.1% of all closed sales, and there were no foreclosures.
