Hosting guest speakers would not only encourage greater community participation but also help keep all of us informed about local policies, safety concerns, and developments that impact our daily lives. I look forward to

GENERAL MANAGER'S REPORT

Rule Review

The proposed rule changes for 2025 should be available to all members by now. Under the California Civil Code, members have 28 days to review and comment on the proposed rule changes. Members can submit their comments in writing for review by the Board of Directors at the April Board meeting. The Board of Directors will either adopt the rules as submitted or if, after reviewing the member comments, the Board of Directors makes additional changes to

the rules, those changes would go out for a further 28 days for comments. The final approved rules will be mailed to the members and become effective 15 days after they are mailed out.

NSCA Board Election

Two open NSCA Board of Directors positions will be filled in May, and we have two official candidates running. Mark Russell and Heather Harding have submitted candidacy

statements, which are available for your review on page 4 of this issue. Ballots will be mailed by Accurate Voting no less than 30 days before the May 20 election. Members of the association, as of March 12, 2025, will be entitled to vote. 50% of the membership must return ballots in order to establish a quorum.

On the night of the election, if a quorum has been established before ballots are counted, there will be the opportunity for qualified members to be nominated from

the floor at the meeting. Once nominations have closed, members present will be asked to cast their ballots. Once a ballot has been cast, it cannot be revoked. If a quorum is not reached, a new date will be announced at the meeting, and the quorum requirement will drop by half to 25%. Once the new Board members have been chosen, the Board of Directors will elect corporate officers for the following year.

the beaches in closest proximity to Niguel Shores (Salt Creek, Strands, Monarch Beach). Their presentation was informative and helpful for all beachgoers. Understanding beach hazards (shore break, steep shore, currents, rocks and jetties, animals) and knowing precautions is essential for ensuring safety at the beach. The list of "Do's and Don'ts" provided insight as to how to approach the beach with caution:

DO: Prepare for the elements; know the conditions; ask the Lifeguard; use proper equipment (ocean fins!); know your limits; go under waves (rather than jump over waves) and keep your hands in front of you.

DON'T: Swim against the current; turn your back to the surf; go over the falls; panic!

If you see someone who may be in trouble, don't put yourself at risk (unless you are a competent swimmer with a flotation device). Call 911, wave down a lifeguard, keep your eyes on the victim. The lifeguard tower closest to Niguel Shores, located at the bottom of the ramp, is DS2.

Lifeguard tryouts are April 16 if you know anyone who may be interested. More information about tryouts or OC Lifeguards can be found at *oclg.org*. We really appreciated the knowledge and insights shared by Chief Young, Lieu-

tenant Wilson and Supervisor Lorber!

MEET YOUR NEIGHBOR

The Dunlevies

o the names **Geoff** and **Rhonda Dunlevie** sound familiar? Perhaps it is because they have both been actively involved in Niguel Shores since moving here in 2008, helping to make our community such a wonderful place to live.

Rhonda was born in Kansas City, Missouri, but her family moved to the Simi Valley when she was seven. She graduated from Cal State Chico with a degree in Human Environmental Design and began her career working for home builders in their Design Centers. This background paved the way for her thirty year career as an interior designer, designing homes from the ground up and doing full remodels.


Geoff is a native Californian and grew up in the Bermuda Dunes/Indio area with his three brothers. His father, Ernie Dunlevie, developed Bermuda Dunes Country Club and

Bermuda Dunes Airport. He also helped to create the Bob Hope Desert Classic now known as the Amex Golf Tournament. Through business transactions, Ernie served celebrity clients such as Cary Grant, Fernando Lamas, Howard Hughes and Ava Gardner. He became close friends with Clark Gable and developed a lifelong friendship with Arnold Palmer. Geoff's dad was one of the founders of the Boys Club of Coachella Valley, and his mom started Angel View, an outreach program for special needs children that has seen tremendous growth since its inception. Geoff's parents set excellent examples of service to the community for their sons, and that has carried on with Geoff.

Geoff graduated from Cal State Long Beach and began his career in the home building industry—and that's where he met Rhonda. Over a period of years their paths continued to cross, and eventually circumstances brought them together. They married in 2007. Timing is everything!

Rhonda owned a home in Monarch Beach and Geoff, in Newport. In 2008, when searching for a place to raise their blended family, they were drawn toward a "fixer" on Windjammer—the first home they looked at in Niguel Shores. With Geoff's background in the building trades and real estate, and Rhonda's talents as a designer, they saw this as their "forever home." They purchased the property, then began remodeling to make it their own. Today, the home reflects their warmth and hospitality with its inviting glass-walled entry, open kitchen, comfortable gathering areas, and indoor-outdoor ambiance.

The Dunlevies are well known for their neighborly acts of friendship and their extensive community service. Geoff recalls when he first arrived in the Shores, his neighbor Jon Cobain invited him to play golf, and from there he met Roy Dohner and several other community leaders who encouraged him to become involved in Shores activities. Since then, Geoff has served on the Traffic and Safety Committee, Landscape Committee, Ad Hoc Rules Committee, and is a longstanding member of the Maintenance Committee. In





addition, this is Geoff's third year as President of Niguel Shores Men's Club, known for its informative speakers, great breakfasts, evening events, and scholarships for high school grads.

Rhonda's commitment to Niguel Shores matches Geoff's. She joined the Women's Club in

2010, enjoying the social activities and also helping some members who needed assistance. With Lynn Bushnell, she organized Shores Angels, a group that has grown to about thirty volunteers who help neighbors with small chores, shopping, transportation, or just a friendly visit for conversation or playing "Go Fish." Rhonda was a member of the Recreation Committee, the Ad Hoc Amenities Committee, and served over three years on the NSCA Board of Directors, with one year as President. During her tenure, she worked to upgrade community facilities, acted as liaison to several committees, and

helped promote kindness, compassion, and understanding in communication so all voices would be heard.

Rhonda and Geoff also maintain busy professional lives. Geoff is a full-time realtor with Compass Realty and the President-Elect of the Laguna Board of Realtors. Rhonda owns Interior Consultants and works with builders on home designs such as those she did for the Grand Monarch Development on Niguel Road. She also advises individual clients with designs for their building and remodeling projects, and has won numerous awards for her work.

Along with their professional and volunteer commitments, the Dunlevies still make family a priority. They are very proud of daughter **Taylor Hanlon** and son **Cole Shamber**. Taylor won JSerra's prestigious Msgr. Martin Award as a graduating senior, has a Master's in Social Work, and is a social worker in Scottsdale, Arizona. After college, Cole used his interest in repairing golf carts here in Niguel Shores to start a cart business, and has just opened SC Carts on Pacific Coast Highway here in Dana Point.

The Dunlevies enjoy traveling, taking skiing vacations, chartering sailboats, or going on cruises to different parts of the world. Rhonda mentions golf and pickleball as two of her favorite sports. Geoff played varsity tennis in school, and enjoys golf, pickleball, a lifelong passion for playing the drums, and sailing. In fact, influenced by his father's love of sailing, Geoff spent lots of time on sailboats growing up and lived during the summers on a 40-foot Ketch in the waters around Catalina Island.

When asked what they most appreciate about living in Niguel Shores, Rhonda and Geoff both agreed, "The friends we've made." VIETNAM TODAY, 50 YEARS AFTER THE END OF THE WAR

Editor's Note: National Vietnam War Veterans Day was March 29, and this month April 30 marks the 50th Anniversary of the end of the Vietnam War in 1975 with the fall of Saigon. Niguel Shoes resident Jenny Rose visited Vietnam with family members recently and she tells us what they saw.

S ix of my family made a recent trip to Vietnam including my six-year-old grandson, my son, his wife and her family. They all wanted a "more authentic" rather than a luxury sightseeing tour. We ended up with our own guide and got a bit of both, which I thoroughly enjoyed (most of the time!). We spent two weeks there, and I'll highlight some of the cities from the north to the south in the order we visited.

HANOI

Hanoi was founded more than 1000 years ago, and it now has over 8.5 million residents and 6.5



million scooters on its streets. To cross a street on foot you need to "weave" between the scooters, trucks, buses and cyclos who will do their best to avoid hitting you—as long as you walk at a steady pace and don't make any sudden moves! Traffic lights are pretty much ignored.



The "Hanoi Hilton" prison is definitely worth a visit, and I recommend reading *The Unlikely War Hero* by Marc Leepson for insights into the horrendous

conditions experienced there by our Vietnam POWs.

At the **Museum of Ethnology** you can see many regional building types. The one shown here with the stepped planks was designed not for flooding but to prevent tigers from entering living areas!



HA LONG

Ha Long Bay is a must see and has over 2000 tiny limestone "islands." Be sure to try kayaking,






nighttime squid fishing and exploring the caverns pictured.

An overnight boat tour is inexpensive and the best way to enjoy the bay.



HUE

We took a train overnight to **Hue**. The train's prep of cabins consisted of re-folding duvets and fluffing pillows used by the previous night's occupants, so **take your own linens** and reserve an entire cabin to avoid having random sleepers wander into yours. The **Citadel** is a

Hoi An was my favorite city, mainly because of the architecture of the buildings in the Old Town area and the streets filled with



cloth and paper lanterns. Lantern Boats take tourists on the river to set out their own floating lanterns



that carry a burning candle and their wishes that may be granted when the flame goes out. Basket Boats are used by local fishermen but are a real thrill if you pay to have your guide make yours "dance."

SAIGON

We flew to DaNang to reach Ho Chi Minh City which is still called Saigon by the locals. Be sure to visit the many cottage industries there. Craftsmen will demonstrate and



then allow you to try many skills including making incense sticks, traditional cone shaped hats, dumplings, paper flowers and lanterns.



The **Mekong Delta** was our most rustic area with trips up branches of the river to remote areas where many locals live on their small house boats and sell their

produce, fish and wares from the same boats. Here we stayed at an Eco Lodge that boasted mineral spring spas and rooms with first class granite bathrooms that included wooden bathtubs.



Be sure to visit the Cu Chi Tunnels near Saigon which were vital to Viet Cong's guerrilla warfare tactics. They span about 155 miles and are as deep as 33 feet in some areas. They were started in the late 1940s and expanded during the Vietnam War from 1955 to 1975. The tunnels allowed Viet Cong to conduct surprise attacks, including from pop





up sniper holes in the ground, and then disappear from attacking forces. The current exhibits allow you to see their living quarters as well as hidden obstacles such as bamboo spikes and camouflaged booby traps that were both above and within the tunnels to deter enemies from entering.



Food would require an entire article by itself but ranged from egg coffee and banh mi street sandwiches (made with baguettes mastered during the occupation by France) to seven course gourmet meals that cost as little as \$50 (about



1,278,282 Vietnamese dong) for a group of six. We also prepared our own food in cooking classes and at a Hot Pot restaurant that served raw eel and fish heads you cooked at your table. (I ate a lot of noodles on the Hot Pot night!)

All in all, Vietnam was a fascinating and educational trip that can be customized to anyone's preference, so you might want to consider adding it to your bucket list!



Wellness - It's All About the Muscle

Thave the blessing of caring for my 94-year-old mom who lives nearby in her single-story home. I share the privilege with an angel of a care giver who fills in four-and-a-half days a week. Together, we put Mom through the paces of daily living—meals, showers, walking a little every day with her walker, simple exercises to help her maintain balance, and more. I realize that the mobility and daily activities I take for granted are much larger challenges for her. Just getting up out of a chair takes concentration and a certain amount of determination—along with the muscles making that movement possible.

When we're young, we tend to think of muscles as something to show off at the beach, the pool, or when you're out and about. At that stage of life, we don't think about muscles as a key component of our ability to move and to keep from falling. However, if we're lucky, longevity prevails, but with it comes the accompanying aging process. Stairs might become harder to climb, that spring in your step may have "sprung," and carrying groceries seems analogous to training for the Olympics!



We may ask ourselves, what happened?

It turns out that we all build muscle mass quite well up to about age 30-35. After that, there is a slow decline of age-related muscle loss, also known as

sarcopenia, a word derived from the Greek sarx (flesh) and penia (loss). This process picks up speed after age 65 for women (tell me about it) and age 70 for men. To assess one's ability to perform physically as we age, a simple test called the Short Physical Performance Battery was developed. It measures one's walking speed, balance, and the ability to get out of a chair five times in a row, with the results pointing to how your muscle strength is impacting your physical abilities. Also, active muscles versus sedentary muscles are better able to take in any available glucose via the cells for energy which helps stabilize one's blood sugar levels. At the same time, when your muscles contract they pull on your skeletal system, causing bone "remodeling" resulting in stronger, denser bones. Your muscles are constantly at work!

The simple advice for maintaining strong muscles at any age is to keep moving. Walk, dance, clean your own house, just keep moving. And be sure to add some resistance training like lifting light weights, whether at the gym or just at home. Start small and build up those muscles over time, so you can jump out of that chair, dance the night away, or maybe even show them off at the beach! Proposition 19

The Home Protection for Seniors, Severely Disabled, Families, and Victims of Wildfire or Natural Disasters Act

Expanded special rules for eligible homeowners.

Effective April 1, 2021: Homeowners 55 years of age and older, severely disabled, or whose property was extensively destroyed by wildfire or other natural disasters may be eligible to transfer the taxable value of their primary residence to a replacement primary residence:

Anywhere in California

Of any value, but with upward adjustments if replacement is of greater value

Replacement property is purchased or newly constructed within two years of sale of the original property Up to three times (previously one time), but without limitation for properties destroyed by fire from a governor's declared disaster



MARKET UPDATE



ACTIVE LISTINGS

The active listing inventory in the past couple of weeks increased by 150 homes, up 6%, and now sits at 3,183. In February, 21% fewer homes came on the market compared to the 3-year average before COVID (2017 to 2019), 673 less. Yet 394 more sellers came on the market this February compared to February 2024.



DEMAND

Demand, the number of pending sales over the prior month, increased by 72 pending sales in the past two weeks, up 6%, and now totals 1,569, its highest level since October. Last year, there were 1,476 pending sales, 6% less. The 3-year average before COVID (2017 to 2019) was 2,422, or 54% more.



EXPECTED MARKET TIME

With supply and demand rising at a similar pace, the Expected Market Time, the number of days to sell all O.C. listings at the current buying pace, remained unchanged at 61 days in the past couple of weeks. Last year, it was 40 days, substantially faster than today. The 3-year average before COVID was 64 days, similar to today.



CLOSED SALES

There were 1,268 closed residential resales in January, up 7% compared to January 2024's 1,182 and down 22% from December 2024. The sales-to-list price ratio was 99.14% for Orange County. Short sales accounted for 0.1% of all closed sales, and there were no foreclosures.
