CELEBRATING THE SEASHORE NEWS

You see that we have a new masthead designed by our resident artist and sculptor, Frank Turner, to incorporate the dolphins from his sculpture at our entrance. You are in this New Year reading issue number 399 of the Seashore News which means it has been in business just over 33 years. Below is a facsimile of issue number one dated April 1973. It was eight pages of seven by eight and one-half inch sheets with news of construction of the new pool and community center, then called the Sea Terrace Recreation Club, appeals to join in sports or help

with the newsletter, and, drawings and some jokes.

The newsletter was originated by John and Beverly Sauer, with the front page article titled *Anchors Aweigh* as quoted here: "How did this get started? We, as concerned homeowners wished to establish a means of communication among residents... with our government and with the developer." That wish has certainly been fulfilled for, it is still here and still communicating! The regular topics listed for that new newsletter were: *From the Helm* by the association president, *On Deck* by the recreational director (a staff member), *Ports O'Call*

about civic affairs and Ahoy Neighbors to publicize social events—all those articles are still here but not in quite such nautical terms. The Sauers also expressed a desire to solicit advertising to fund the publication, the Board having graciously paid for the first issue. That idea recently resurfaced after being underground for about thirty years. Dick MacNair, chairman of the Communication Committee through most of the 1980s, reports that there was no money to spend on the newsletter and that a volunteer, Edie Newton, typed the whole thing and printed it on the office copy machine. Now, the newsletter expenses are covered by the ads which continue to save residents many thousands of dollars annually in publication costs.

GENERAL MANAGER'S MESSAGE

Be Careful - The Knock at the Door May Not be Santa

I was hoping to use this column this month to talk about pleasant holiday reminders and the fact that the staff has successfully moved into its new temporary office. Instead, I need to have a serious conversation because of several events in Niguel Shores during the past few weeks.

We have become the target for a "Scam" group, known as a "CREW". They come to your door soliciting money for good causes, which they ask you to fund by purchasing magazine subscriptions from them. We have had to have the Sheriff escort two off the property, but they keep returning to prey on unsuspecting homeowners.

The story they tell homeowners varies but what I can tell you, everything they tell you is a lie. First, they will try to convince you that they live in Niguel Shores or that their families do. Actually, they are not from this area and are flown into cities as a group and this is where the name "Crew" comes from. Each day they are driven to an area and dropped off to sell subscriptions. At the end of the day, they are picked up, taken back to a hotel, fed and briefed on the next day's plan. After a week or two, they are put back on a plane and flown back to their home city.

This may seem harmless if you just say "NO" to their presentation. However, they are very aggressive and do not take no easily. In addition, this particular group worries me and the next day after escorting one of them off the property, one member of this crew was arrested for raping a woman after she let him into her house to buy a subscription.

To sum this up...remember there is "NO SOLICITA-TION" in Niguel Shores under any circumstances. These people have produced a copy of a letter saying the Association has authorized their activities, but this is absolutely false and will never happen. So, be careful whom you open your door for.

You will notice a change in the gate passes issued and the manner in which your guest lists are maintained. Beginning this day, you will be able to access and change your permanent list "on line" rather than having to call the gate or the office. 

Drive rather than from the soon to be partially demolished parking lot. Most parking for members, residents, and guests will be very restricted and at times totally closed. Street parking is recommended as the new building contractor will be fencing off the demolition and building site. All regular business services are available at the temporary office and access to the community center, locker room, pool, tennis courts and recreation facilities will be around the backside of the maintenance facilities.

Actual demolition of the present building will take place during the month after all the government agencies have their say. The latest agency to become involved is the AQMD who must be assured that our project activities will not contribute to air pollution.

Demolition and building permits cannot be issued until everyone is satisfied, but applications are in for all agency approvals. Once demolition is complete, grading and building can begin.

Please use much care and caution when visiting the community center complex. Considerable digging, trenching, and trucking will be taking place. Progress has its price and we don't want anyone getting injured.

FINANCE

Niguel Shores will be starting 2007 with a "reserve" in excess of \$2 million. Our largest capital expenditures in 2007 will be the new office building and major street asphalt work.

Due to increased oil prices, the cost of street asphalt work earlier this year was projected to double. That is the bad news. The good news is oil prices have since dropped plus the Headlands project and the South Coast Water District can save money by tying into our existing sewer system. As a result of negotiations they have agreed to reimburse NSCA 57.2 percent of our cost to overlay the asphalt on the beach bluff parking lot, adjacent areas and on those streets torn-up during the installation of the new sewer line.

Total projected income for 2007 is \$2,736,000. This total includes dues, bank interest on certificate of deposits, and other miscellaneous income. Of this total \$814,258 will be transferred to reserves for future capital expenditures. The remaining funds go to the operating budget for daily expenses, such as administration, landscaping and gate guard services.

Our future challenge will be to manage the reserves to remodel the MPR building, complete the remaining asphalt work and maintain our aging infrastructure.

LANDSCAPE

Tree Replacement Project

The committee has begun a three year tree replacement project. The project involves approximately 85 trees that have a variety of problems. The majority of these trees are located in the Garden Home and Shores Garden areas of the community.

The three major problems necessitating this action are: 1) Their roots are causing damage to the streets and curbing, 2) They are dead or in the process of dying due to ground water and 3) Some species are becoming very messy with a heavy berry drop.

The primary issue with high ground water is when trees mature and roots grow deep enough to enter the ground water table they will actually begin to drown.

The plan is to plant replacement melaleuca trees be-

fore the trees die so when the time comes to remove the dead trees, we have full trees in place. The melaleuca is a species that can survive in harsh environments, including excess ground water.

Landscape Concerns

Owners must not add, remove or change plantings in any area maintained by the NSCA's landscape contractor without approval of the Landscape Committee.

If you have a concern about any landscape situation contact the office. Fill out a request form and it will be forwarded to the representative of your area. You may also get this form on line at www.niguelshores.org; click on NSCA forms and then Homeowner Request Form. You may then print it out and fax it to the office or drop it off.


Using Costco has another benefit, in that if you want copies of any of the photos, you can request them on-line for pickup at the Costco location of your choice the following day.

TREE VIEW BLOCKAGE

Tree Tips

Our ocean views are among the most valuable assets that we have. Our location is one of the best. Palm trees can add to the desirability of your property. A palm should be growing in an area that does not unreasonably interfere with your or your neighbor's view. Think of that neighbor up the hill, just behind your property.

When you are aware that your palm has the potential to block a neighbor's view there is a little trick that can postpone the potential problem.

- · Isolate the newest central frond.
- Measure up about one half its length.
- Cut the frond off at about a forty-five degree angle.

Be sure that you do not cut down to the crown of the tree, as you will kill it. This procedure will slow the growth rate way down according to the information received by one of our committee member's gardeners.

MacNair also said that residents wanted to know what the Board was doing but didn't want to go to the meetings so the "Board Actions" column was begun. "From the Helm" has appeared off and on over the years. During the early 1990's there were very few but there was a full-page financial report each month. For the first few years there was an editor and two or three reporters. Later on a committee was formed with additional members doing pasting and proofing.

Doris Adams, long-time Communication Committee member, and her husband, Ed Adams, related tales of the early issues when they first came to Niguel Shores in the late 1970s. Paste-ups were made of the typed articles and the final version taken to the printer. Correcting errors was laborious as pages had to be retyped. The printed newsletter was delivered in separate sheets that were collated and stapled—see elsewhere in this issue for that story. Block captains delivered it then as they do now. However, as Ed says, we were all younger then and enjoyed doing it together. The last stapled version was September, 2003 and, in December 2001 the Doris Adams designed symbols were first used instead of the old clip art at the head of various articles when space permitted.

The dolphins change, the people change and the technical aspects change but, the *Seashore News* will go on.



So, there you have it. All of those people walking your streets to deliver your newsletters free. If you see one of them, say "Thank you." We certainly do thank them. It has been going on since the beginning and we do hope it continues—another wonderful community-spirited activity of the volunteers who help make Niguel Shores what it is.

VOICE OF THE PEOPLE

Letters are welcome and limited to 200 words, typed if possible, including name, address and phone number of writer. Refer to NSCA Rule #5221,2,3. Submissions are due on the 15th of the month.

Reference to a letter to General Manager, Leo Riley: ...in your 2nd paragraph you state the "Replacement Tree Project" involves all the "Bay" streets off Atlantic from Coral Bay to Colima Bay. Why then did you plant replacement trees in our cul-de-sac as we are not a part of the street grouping you describe?....

We have surveyed the streets and curbing of our street and cannot find evidence of the "damage" that you mention. Nor, by your definition, do the trees appear to be dying... On Amundsen Bay they (the Ficus Rubijinose) have (been replaced) but not by Melaleuca. We are not horticulturalists but, whatever was used on Amundsen is pleasing and much preferable and superior to Melaleuca trees.

....In our considered opinion, the replacement of our ficus with Melaleuca trees is a bad deal—for us the homeowners. And not just on our street. There is no comparison whatsoever in the quality, shape, scale and overall appearance between the two types of trees. The Melaleuca tree can best be likened to an unruly, fast-growing weed.

Conclusion: based on the above analysis, logic would dictate that you EXCLUDE the Atlantic Avenue cul-desac from your project. We are quite happy with the way things are....Peter & Carol McWilliams




